action.

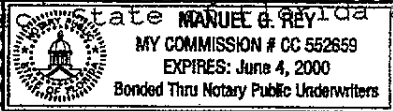
7. That the holders of 100% of the common stock of the corporation, have executed a consent to dissolution of said corporation.
