THIS AMENDMENT TO THE ARTICLES OF INCORPORATION (this "Amendment") was adopted on the 6 day of December 2011 (the "Effective Date") by the Shareholders of RANGANATHA P. POTU, M.D., P.A., a Florida professional service corporation (the "Corporation") pursuant to Section 607.1006, Florida Statutes.

WITNESSETH:

WHEREAS, the Corporation's original Articles of Incorporation, document number 692145, were filed with the Florida Secretary of State on June 26, 1981, (the "Articles"); and

WHEREAS, the Corporation, its Board of Directors and Shareholders believe it to be in their best interests to change the name of the Corporation.

NOW, THEREFORE, pursuant to the provisions of Florida Statutes Section 607.1003 the Corporation hereby adopts the following Amendment to its Articles:

1. The name of the Corporation is HEART ASSOCIATES, P.A.
2. Except as specifically amended herein, all terms, provisions and conditions of the Articles shall remain unmodified, and otherwise in full force and effect.
3. The foregoing Amendment was approved and ratified by the Shareholders by execution of a written consent, dated December 1st, 2011, in accordance with Florida Statutes Chapter 607 and the Corporation's Bylaws. Therefore, the Secretary of State is hereby requested to approve and file this Amendment in accordance with Florida Statutes Chapter 607.
