A. **Amendment to Name of the Corporation:** Article I is deleted in its entirety and the following Article I is substituted therefor:

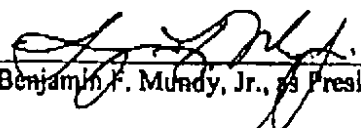
"The name of the corporation is CMHM Architects Inc."
