Effective Date of Dissolution

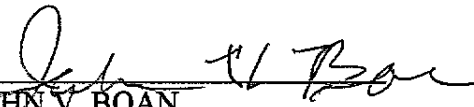
The effective date of these Articles of Dissolution shall be the date on and time at which same are filed with the State of Florida, Department of State, Division of Corporations.
