**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF MEDICAL DOCUMENTATION SERVICES, INC.**


Pursuant to the provisions of Section 607.1006, Florida Statutes, Medical Documentation Services, Inc., a Florida Profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article III of the Articles of Incorporation shall be amended to increase the maximum number of shares that this corporation is authorized to issue and have outstanding at any one time from 1,000,000 shares of common stock having a par value of \$1.00 per share to 2,000,000 shares of common stock having a par value of \$1.00 per share.
