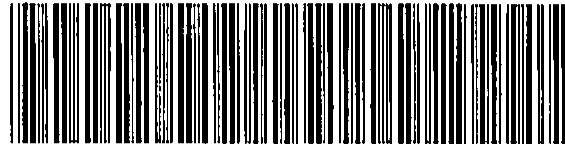

Article IX-SPECIAL RESTRICTIONS is amended to read as follows: None of the stock of the corporation may be issued to anyone except an individual duly licensed to practice law in Florida. No shareholder may sell or transfer any shares in the corporation without the prior written consent of the majority shareholder of the corporation. The majority shareholder may transfer all or part of his shares to the trustee of a trust, and such trustee of such trust may sell or transfer the shares as if he was the majority shareholder, provided that such trustee is an individual licensed to practice law in Florida. No shareholder may transfer any shares to anyone who is not eligible to practice law in Florida. No shareholder may enter into a voting or other agreement vesting another person with the authority to exercise the voting power of his stock; except that this restriction shall not deprive the majority shareholder of the right to transfer all or part of his shares to the trustee of a trust, as stated above. The language in the old "Article IX-SPECIAL RESTRICTIONS" is deleted.
