Trust of LAWYERS TITCH PHARMETY FUND, Tried with him decretary of State of Florida, March 22, 1947, as amended by amendments filed with the Sacretary of State of Florida on April 25, 1950; February 15, 1951; April 5, 1951; June 3, 1955, and December 22, 1950, be and is hereby further apended as follows:

AMENDMENT XY

Section 26 of the Declaration of Trust as it is shown after the last previous amendment to said Declaration of Trust filed with the Secretary of State on December 27, 1956, is further amended as follows:

Paragraph (b) is amended by striking those words: "one of whom shall be the Chairman of the Hoard of Trustees, who shall also be Chairman of the Committee" so that the paragraph, as amended, reads:

(b) The Board of Trustees may provide for an Investment Committee of three members and give the Committee such authority as it does advisable.

and

Paragraph (c) is amended to read as follows:

(c) The Board of Trusters may invest in the stock of and loans to Lawyers' Title Services, Inc., as much as, but not in excess of, fifty percent (50%) of the amount authorized by the laws of Florida.
