AMENDMENTS TO THE DECLARATION OF
TRUST OF LAWYERS' TITLE GUARANTY FUND

We, Robert C. Scott and Paul B. Comstock, do hereby certify that we are the Chairman of the Board of Trustees and the Executive Secretary respectively of LAWYERS' TITLE GUARANTY FUND, a business trust under the laws of the State of Florida, and that the Declaration of Trust of Lawyers' Title Guaranty Fund filed in the office of the Secretary of State of the State of Florida on March 22, 1947; as heretofore amended by amendments filed in said office on April 26, 1950; February 15, 1951; April 5, 1951; June 3, 1955; December 22, 1956; October 9, 1959; November 9, 1960; October 4, 1966; November 6, 1968; November 24, 1976; February 9, 1978; November 21, 1979; and December 31, 1979; was further amended by the following amendments to said Declaration of Trust which were duly adopted by an affirmative vote of all of the members of the Board of Trustees at a meeting of the Board of Trustees duly called and held on December 4, 1981:

The name of the trust is changed from Lawyers' Title Guaranty Fund to Attorneys' Title Insurance Fund effective the first day of July, 1982, and the Declaration of Trust is amended by deleting the words Lawyers' Title Guaranty Fund at each and every place where they appear in the Declaration of Trust and substituting in lieu thereof at each and every such place the words Attorneys' Title Insurance Fund.

The title that presently reads NAME AND DEFINITIONS and appears immediately preceding Section 1 of the Declaration of Trust is amended to read PURPOSE, NAME AND DEFINITIONS.

Section 1 is amended to read as follows:

Section 1. PURPOSE: The purpose of this trust is to establish and maintain a fund for guaranteeing and insuring titles to, interests in, and liens upon, real estate, through Members and authorized officers of Attorneys' Title Insurance Fund, hereinafter sometimes referred to as The Fund.

Section 3 is amended to read as follows:

Section 3. NAME: This trust may be referred to as ATTORNEYS' TITLE INSURANCE FUND or The Fund.


