ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ABILITIES, INC. OF FLORIDA

Corporation Document No. 700121

1. ARTICLE IV of the Articles of Incorporation of ABILITIES, INC. OF FLORIDA entitled "Purpose" shall be amended to read as follows:

"ARTICLE IV

PURPOSE

"The purpose of this corporation is to provide an environment in which individuals with disabilities can achieve their vocational potential and learn to function independently within society. The Corporation's mission is to provide a thorough evaluation of a person's strengths and weaknesses and to implement dynamic and efficient individualized training, employment and support programs resulting in a person's ability to be responsible for himself or herself and to obtain and maintain employment.

To enable it to obtain its purposes, the Corporation shall have all of the powers given to not for profit corporations by the Laws of the State of Florida and particularly Section 617.021, Florida Statutes, 2003 as further amended from time to time."
