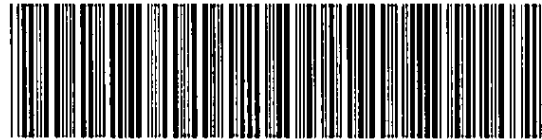

B. Membership meetings

"The annual meeting of the members shall be held ~~on the second Wednesday in~~ February. Fifteen percent of all members, present and in person or represented by written proxy, shall be necessary to constitute a quorum at any membership meeting..

D. Admission to membership

"Admission to membership in the club shall be initiated by an application to the Membership Director, the membership committee or a written proposal made by a member. The application shall contain such information as the By-Laws or the Board of Governors may require..."

"A vacancy occurring on the Board may, at the option of the Board, be filled by a majority vote of the remaining Governors ~~for the unexpired term~~ for a term that expires at the next annual meeting at which Governors are elected.


