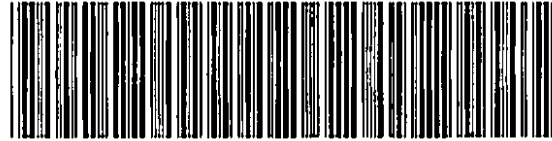

Section 3. Classification of Memberships

**Classification of Memberships:** The memberships shall consist of:

Section 3. Qualifications: Regular Members:

To qualify as a regular member a woman must for more than a year last past have had her legal residence within the Greater Orlando-Winter Park area, as defined by the by-laws, and she must reside in such residence for not less than six months during each calendar year.

Section 3. Qualifications: Courtesy Members

Delete in its entirety: **Courtesy Members:** The qualifications of courtesy members shall be fixed by the by-laws of this corporation.

Section 3. Qualifications: Life Members:

**Life Members:** Life members shall be those persons who have been regular or non-resident members of Rosalind Club of Orlando for fifty years. Daughter and daughter-in-law season membership years shall be counted along with regular membership years toward the qualifications for life membership.

Section 3. Manner of Admission: Inactive Regular:

**Inactive:** The Board of Managers may extend, upon request, an inactive membership which is exempt from dues, to any regular or non-resident member in good standing who has become incapable of functioning as a regular member. This membership may be requested by the member herself, a member of her immediate family, or legal representation. In the event such disabilities cease, said member may request to be reinstated as a regular or non-resident member and a regular member will take the first vacancy which occurs. She will resume full privileges and obligations. When a regular member is classified as an inactive member, this will constitute a vacancy in the regular membership.

Section 3. Manner of Admission: Other Classes of Members:

**Honorary Members:** Honorary members may be elected by the Board of Managers at duly convened meetings, without secret ballots and an affirmative vote of a majority of the votes cast shall be sufficient to elect.

Section 6. Officers:

**Officers:** The officers of this corporation shall be a president, a vice president, a recording/corresponding secretary, a membership secretary, a treasurer and an assistant treasurer. Their respective duties shall be set forth in the by-laws of this corporation.

Section 6. Election:

**Election:** The officers and other six members of the Board of Managers shall be elected by the members in the manner provided in the by-laws of the corporation. They shall take office, on the beginning of the corporation's fiscal year. The fiscal year shall be fixed by the by-laws of the corporation.

Section 7. Annual Meeting:

7. ANNUAL MEETING: The annual meeting of the members shall be held in the manner provided in the by-laws of the corporation.
