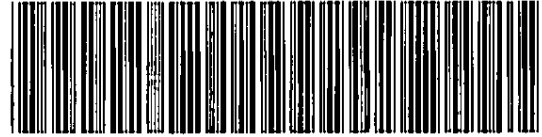

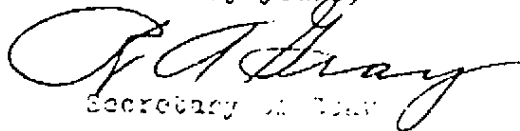

ARTICLES OF INCORPORATION
OF
CROSS BAYOU METHODIST CHURCH, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, under the following proposed Charter:

APPROVED AND FILED

ARTICLE I

NAME

The name of the corporation shall be Cross Bayou Methodist Church, Inc., and it is located in Largo, Pinellas County, Florida.

ARTICLE II

PURPOSE

The object, general nature and purpose of this corporation shall be to establish and maintain in the City of Largo, Pinellas County, Florida, a Methodist Church, Educational Building and other property necessary for the purposes of the church, in connection with the Florida Conference and General Conference of the Methodist Church, and subject to the Discipline of said church. This church corporation shall support the doctrine, and it, and all its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of The Methodist Church as are now or shall be from time to time established, made and declared by the lawful authority of the said church.

ARTICLE III

MEMBERSHIP

The doctrinal basis, manner of admission, qualification for membership, shall conform to the requirements of the Discipline of The Methodist Church as adopted and approved by the General Conference and to the rulings of the Bishops of said church. All members of Cross Bayou Methodist Church of Largo, Florida, in

good and regular standing are members of this corporation.

ARTICLE IV

TERM OF EXISTENCE

The existence of this corporation shall be perpetual or until such time as it shall be dissolved by law.

ARTICLE V

BY-LAWS

The by-laws of the corporation shall be adopted by the Board of Trustees and may be amended and changed from time to time by the Board of Trustees.

The by-laws of the corporation shall include the Discipline of The Methodist Church as from time to time enacted, authorized and declared by its General Conference; and no other by-laws shall be adopted inconsistent with the provisions of the Discipline.

ARTICLE VI

POWERS

This corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, encumber, sell, convey and dispose of all such property in conformity with the Discipline of The Methodist Church; to borrow money, execute notes, bonds and other evidences of indebtedness and secure the same by mortgages and deeds of trust, annuity bonds and other instruments of indebtedness and pay interest thereon; to improve, adapt and use its property or the income thereof in its religious, educational, benevolent, or social activities, without financial profit to its members, except as may be necessary in the payment of salaries or other compensation for services rendered; and, subject to the provisions of the Discipline of The Methodist Church, the corporation shall have the power to erect and maintain buildings for the worship of God, for training in Christian faith and conduct

and for Christian social intercourse, and to acquire or build and maintain residences for the use and occupancy of its ministers.

ARTICLE VII

ARTICLE VIII

ORGANIZATION

The business of the corporation shall be conducted by the President, Vice President and Secretary-Treasurer, and a Board of Trustees consisting of not less than three nor more than nine trustees who shall be elected by the Quarterly Conference of the church, as provided for in the Discipline of the church. The officers above provided for shall be elected from their number by the Board of Trustees at the annual meeting to be held on a date in May of each year as fixed by the Trustees. Provided, however, if the annual meeting is not held as herein provided, that all officers shall hold their offices until their successors in office are elected and qualified. The present officers shall have charge of the business of the corporation and shall serve as such until their successors are duly qualified. The present officers are:

President - Cosmo Smith
Vice President - Arthur L. Hamel
Secretary-Treasurer - Edward L. Seligman

The presently elected Board of Trustees of this church shall serve until such time as their successors in office shall be elected by the Quarterly Conference, as provided in the Discipline of the church. The present Board of Trustees consists of the following:

Cosmo Smith
Arthur L. Hamel
Edward L. Seligman

The powers and duties of the officers and Trustees shall be as prescribed by the Discipline of the General Conference of the Methodist Church and by such by-laws as the Quarterly Conference may from time to time adopt. The Board of Trustees shall have the power to accept resignations and fill vacancies in the offices of this corporation except members of the Board of Trustees, these vacancies shall be filled as provided in the Discipline.

ARTICLE IX

AMENDMENTS

This charter shall be amended only upon a two-thirds vote of all the members present and entitled to vote thereon at any regular or special meeting called for that purpose, provided said proposed amendment shall be submitted to each member entitled to vote at least twenty days prior to any action thereon.

ARTICLE X

QUORUM

A quorum for the transaction of the business of the organization shall consist of at least a majority of the Board of Trustees.

ARTICLE XI

The Board of Trustees shall represent the corporation in all proceedings, but they shall take no action unless authorized and directed by the Quarterly Conference and the actions of the Quarterly Conference shall be subject to the requirements of the Discipline of the church.

ARTICLE XII

DISSOLUTION

Upon dissolution of this corporation for any purpose whatsoever, all its corporate assets shall be distributed to The Methodist Church, or to its successor.
