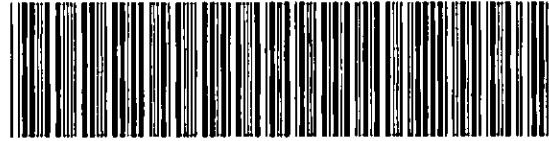

FULLY RESTATED ARTICLES OF AMENDMENT TO CHARTER OF INCORPORATION
(ARTICLES OF INCORPORATION) OF WINTER PARK CHRISTIAN CHURCH
(DISCIPLES OF CHRIST), INCORPORATED
a Not for Profit Corporation

COMES NOW the undersigned as the Moderator of Winter Park Christian Church (Disciples of Christ), Incorporated, a Florida not for profit corporation and executes this instrument for the purpose of filing the same with the Secretary of State of the State of Florida to indicate the following amendment to its Charter of Incorporation (Articles of Incorporation) fully amending and restating the listed Articles as follows:

Article I - Name

The name of the corporation shall be Winter Park Christian Church (Disciples of Christ), Incorporated, a Florida not for profit corporation.

Article II

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose(s) for which the corporation is organized are: To promote, perpetuate and unite the Christian Faith according to the Holy Scriptures now taught and exemplified.

The corporation shall maintain and conduct its services as a member of the denomination of the Christian Church (Disciples of Christ) and shall fully participate with said denomination.

Article III - Object

The general nature of the object of this corporation shall be to conduct for religious worship and instruction, churches, schools and other institutions connected therewith of a religious, educational, charitable or benevolent character to the end that its own members and others may be generally instructed and guided concerning the faith held by the Disciples of Christ organization of churches; to advance

spiritual growth and enlightenment, moral and personal purity among its members and the people of the community wherein it is located; and, as is revealed in the New Testament, to win people to faith in Jesus Christ and commit them actively to the church, to help them grow in the grace and the knowledge of Christ that increasingly they may know and do His Will, and to work for the unity of all Christians and with them engage in the common task of building the Kingdom of God.

Article IV – Membership

The membership of this corporation shall consist of those who are now identified as members of the congregation of the Winter Park Christian Church, (Disciples of Christ), Incorporated and those who shall unite with it by baptism or by transfer of membership. Voting privileges shall be accorded to all members who have shown an active interest through a recent continuity of attendance, service or giving.

Article V – Term

This corporation shall have perpetual existence.

Article VI – Officers

The following officers shall be elected by the corporation at an annual business meeting for a term as designated for each, or until such time as a successor is elected and assumes office.

1. Moderator
2. Vice-Moderator
3. Secretary
4. Elders
5. Deacons
6. Financial Secretary
7. Treasurer
8. Historian

Article VII – Bylaws and Articles of Incorporation

The Bylaws and Articles of Incorporation are to be made, altered or rescinded upon a two-thirds vote of the members present at any annual meeting of the corporation or special meeting of the corporation.

Article VIII – Dissolution

In the event of dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of dissolution shall be distributed to the Christian Church (Disciples of Christ) in Florida, Inc., as the Regional manifestation of the Christian Church (Disciples of Christ) Denomination. The Christian Church (Disciples of Christ) in Florida, Inc. has qualified for exemption under Section 501(c)(3) of the Internal Revenue Code. None of the assets will be distributed to any member, officer, or trustee of this corporation.

This Fully Restated Article of Amendment was approved by more than a 2/3 majority of the members of the congregation at a meeting of the congregation ^{on August 16, 2020} to be effective the 1st day of September 2020.
