# THE UNITARIAN UNIVERSALIST CHURCH OF TAMPA, INCORPORATED

#### **DOCUMENT NUMBER 700368**

Pursuant to the provisions of Section 617 1006 of the Florida Statutes, this Florida Not for Profit corporation (herein called the "corporation") adopts the following Amendments to its Articles of Incorporation:

1. Article II is hereby deleted and replaced in its entirety with the following:

#### Article II - Object

The corporation is a Unitarian Universalist Church. The mission of the corporation shall be set forth in its Mission Statement which shall be adopted and revised by the members of the corporation from time to time.

2. Article III is hereby deleted and replaced in its entirety with the following:

#### Article III - Membership

The requirements for membership (including the designation of classes of membership, if any, and the method of acceptance of members of each such class) shall be set forth in the corporation's By-Laws. The rights and obligations of members, or any class or classes of members, shall be specified in the corporation's By-Laws.

3. Article V is hereby deleted and replaced in its entirety with the following:

## Article V - Management

Subject to applicable law and to the provisions of the By-Laws regarding actions that require approval of the members, the business and affairs of the corporation shall be managed, and all corporate powers shall be exercised, by or under the direction of the Board of Trustees, who shall be elected or appointed in accordance with the By-Laws.

4. Article VI is hereby deleted and replaced in its entirety with the following:

# Article VI - By-Laws

The procedure for amending the By-Laws of the corporation shall be set forth in the By-Laws.

5. Article VI-A is hereby deleted and replaced in its entirety with the following:

#### Article VI-A

The provisions regarding the election, appointment and term of office of officers and other members of the Board of Trustees of the corporation shall be stated in the By-Laws.

- 6. Article VI-C (regarding limits on corporate indebtedness) is hereby deleted in its entirety.
- 7. Article VII (regarding a limit on the value of real estate) is hereby deleted in its entirety.

DATE OF ADOPTION: The date of adoption of these amendments was May 2, 2004.
