CHARTER OF  
MYRTLE GROVE BAPTIST CHURCH, INC.  
A CORPORATION NOT FOR PROFIT

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the Laws of the state of Florida, applicable to corporations not for profit, under the following proposed Charter:

ARTICLE I - NAME

The name of the corporation shall be MYRTLE GROVE BAPTIST CHURCH, INC., a corporation not for profit, and it is to be located in the County of Escambia, State of Florida.

ARTICLE II - OBJECT

Believing in the Bible as the inspired word of God and as the sole authority for faith and practice, and acknowledging adherence to the teachings of Jesus Christ, the general nature of the object of the corporation shall be: To maintain regular services to proclaim earnestly the gospel message and urge its personal acceptance; to cooperate heartily by prayer, gift and service, in the effort to establish the Kingdom of Christ throughout the world; to promote systematic Bible study and training for Christian service and to encourage in every possible way life enlistment in some form of religious activity; to urge the membership of the corporation to live daily according to the principles set forth in the Scriptures; to conduct for religious worship and instruction churches, schools, pastoriums, and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and

guided concerning those articles of faith which are most surely held among our Southern Missionary Baptist Churches and to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions; also to educate, prepare, and ordain Christian men and women for the ministry of the gospel of Jesus Christ and for the service of Jesus Christ.

#### ARTICLE II - MEMBERSHIP

Every person who believes in repentance toward God, and faith in Jesus Christ, as Saviour and Lord, and who is willing to confess Him publicly as Lord and King and follow Him in baptism by immersion, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in this corporation. The manner of admission to membership in said corporation shall be as follows: Any person publicly professing faith in the Lord Jesus Christ; giving evidence of a changed heart, and having accepted the aims and ideals of the church as expressed in the Church Covenant upon a favorable majority vote of the membership of the corporation present at any meeting of said church, shall be accepted as a candidate for baptism and after that into full fellowship of the church; members from other Missionary Baptist Churches of like faith and order may be received into membership upon the promise of a letter and upon favorable vote of the membership of the corporation present at any meeting of the church, but baptism shall be required of those received from other faiths; any person who has been baptized into the fellowship of a Missionary Baptist Church, upon giving evidence that the Church involved has disbanded or that its records have been destroyed, may be received into membership upon his or her statement and upon a favorable majority vote of the membership of the corporation present at any meeting of the church, and

any person who was once a member of a Missionary Baptist Church, but who is now a member of another denomination, may be admitted to membership by statement, upon giving evidence of having been a member of a Missionary Baptist Church and upon a favorable majority vote of the membership of the corporation present at any meeting of the church.

The present membership of the Myrtle Grove Baptist Church (unincorporated) and those hereafter admitted to such membership shall constitute the membership of this corporation.

#### ARTICLE IV - TERM

This corporation shall have perpetual existence.

#### ARTICLE VI - OFFICERS

The affairs of this corporation shall be managed by a Board of Deacons, such management to be subject to the approval of the church, and said Board to be composed of not less than five (5) members. The corporation shall provide in its by-laws from time to time the membership of the said Board of Deacons, and said membership shall be elected from and by the membership of the corporation.

The term of membership of deacons shall be for life or for such other length of time as the membership of the corporation may provide by its by-laws. The said Board of Deacons shall appoint from its own membership a chairman, vice-chairman and secretary. All legal instruments of the corporation shall be signed by said chairman or vice-chairman, sealed with the corporate seal, and attested by the church clerk; or in such other manner as may be authorized by law. All elections to membership on said Board of Deacons shall be by majority vote of the members of the corporation present at any business meeting thereof.

The present Board of Deacons of the Myrtle Grove Baptist Church, whose names are set forth hereinafter in Article VII, shall constitute the Board of Deacons and shall hold office until their successors are elected and qualified.

In addition to said Board of Deacons the corporation shall have a pastor, church clerk, treasurer, Sunday School superintendent, training union director, W.M.U. president, brotherhood president and such other officers as may be necessary, and such officers shall be elected by a majority vote of the corporation present at any business meeting of the corporation for such term as the corporation may provide by its by-laws, except that the pastor shall be called by the membership of the corporation and shall be elected for an indefinite period, and except that three-fourths of the members present at any business meeting of the corporation shall be required to call the pastor or request his resignation.

#### ARTICLE VII - FIRST OFFICERS

#### ARTICLE III - BY-LAWS

The By-Laws of the corporation are to be made, altered or rescinded upon a two-thirds vote of the members present at any annual meeting of the corporation, or at any business meeting of the corporation provided that announcement of the proposed amendments, alterations, rescissions and the like is made from the pulpit on the Sunday previous to such business meeting.

#### ARTICLE IX - AMENDMENT

Proposed amendments to these articles shall be first submitted to the Board of Deacons at a regular or special meeting thereof attended by at least two-thirds of the active deacons. If after consideration thereof, a majority of the active Deacons present at the meeting favor the proposed amendment, the appropriate officer shall present the proposal to the membership of the corporation at the next business meeting along with the recommendations of the Deacons.

Vote on the proposed amendment shall be taken at a subsequent business meeting, which shall be not less than two weeks after the initial presentation to the membership. A two-thirds vote of the members present shall be required in order to accept

the proposed amendment.

ARTICLE X - VALUE OF REAL ESTATE

The amount in value of the real estate which the corporation may hold, subject always to the approval of the Circuit Judge, shall be One Million Two Hundred Thousand Dollars (\$1,200,000.00).

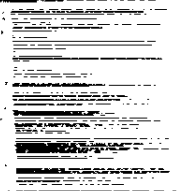
