#### Changes to the Myrtle Grove Baptist Church Charter 2012

- 1. The title has been changed from "Charter" to "Constitution." This is the modern day word.
- 2. The wording in the introduction has been changed. We are already incorporated.
- 3. Article I Name The physical address is included.
- 4. Article II- Objective The objective in the Charter is wordy and hard to understand. The wording in the Constitution is simple to understand and draws attention to the four principles of how a church should be engaged in the Lord's work.
- 5. Article III of the Charter, Membership" has been removed. Extensive guidelines for membership are in the proposed by-laws which should be ready for the church to review and act on next month. Article III of the Constitution now reads Our Purpose Statement This states the reason why the church is organized within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United states Revenue Law). The Purpose Statement was in Article I, Section II of the 1998/99 By-Laws.
- 6. Article IV- Statement of Faith The Statement of Faith wasn't in the original charter. It was included in the 1998/99 By-Laws. The statement of faith should be in the constitution. The Statement of Faith in the existing by-laws is a modification of the Baptist Faith and Messenger 2000 which is lengthy, wordy and difficult to follow. We broke the statement of faith into subparagraphs so that it can be easier to understand. We used the following from the North American Mission Board Model: About God, About Jesus Christ, About the Holy spirit, About the Bible, About Human Beings, About Salvation, About Eternal Security, About Eternity, About the Church, About the Christian Home, About Baptism and the Lord's Supper, and About Christian Life. We used the Christian Law Association Model for the following: About the Second Coming of Christ, About Eternity, About Satan, About the Christian Life, About Family Relationships, About Divorce and Remarriage, About Human Sexuality, About Love, About Lawsuits Between Believers, About Missions, and About Giving.
- 7. Article V Membership Covenant There isn't one in the Charter. It is in the 1998/99 By-Laws. It should be one in the Constitution.
- 8. Article VI Polity and Relationships This wasn't in the Charter. It is needed per the North American Mission Board guidelines. This article outlines the form of human governance we use when we gather for decision-making.

- Article VII Affiliation This wasn't in the Charter. It is needed per North American Mission
  Board guidelines. It states which voluntary associations the church has with other doctrinally
  sound churches and associations.
- 10. Article VII Conducting Church Affairs This wasn't in the charter. It is needed per North American Mission Board guidelines. This states where to find the details not contained in the constitution about how we conduct the church's affairs. These will be contained in the by-laws and policies and procedures manual.
- 11. Article IX Officers These changes were recommended by the deacon and yokefellow sub-committee and approved at the February 2013 deacon and yokefellow meeting.
- 12. Article X The article listing the First Officers was Article VII in the Charter.
- 13. Article XI Current Deacons and Yokefellows- This article lists the currently elected deacons and yokefellows.
- 14. Article XII Myrtle Grove Baptist Church By-Laws The policy for amending By-Laws were contained in Article VI, Section X of the 1998/99 By-Laws. There are several procedural changes for amending the By-Laws in the Constitution. Article III, Section IV of the Myrtle Grove Baptist Church By-Laws is the procedures for conducting church meetings. This article provides for a question and answer session prior to changes being voted on at business meetings. It also prohibits voting by absentee or proxy voting.
- 15. Article XIII Amending the Constitution This article provides for a question and answer session prior to amendments being voted on at business meetings. It also prohibits voting by absentee or proxy voting.
- 16. Article XIV Value of Real Estate The value has increased since 1998/99.
- 17. Article XV Term This was Article IV in the Charter.
- 18. Article XVI Subscribers This was Article V of the Charter.
