

**ARTICLES OF AMENDMENT**  
**TO**  
**ARTICLES OF REINCORPORATION**

**ROYAL PALM YACHT AND COUNTRY CLUB, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, Royal Palm Yacht and Country Club, Inc., a Florida corporation not for profit (the "Corporation") adopts the following articles of amendment to its Articles of Reincorporation:

**FIRST:** Article III, Item H, of the Articles of Reincorporation is amended in its entirety to provide as follows:

- H. The number of Members of the Corporation at any one time shall be limited to Five Hundred Ninety (590) including Founder Members, Nonvoting Founder Members, (as described in Item I of this Article III) and Provisional Members. Golfing privileges shall be limited to Four Hundred (400) members at any one time, provided however, that the Board of Governors may grant temporary golfing privileges on such terms and conditions as it may authorize to Founder Members and Provisional Members next awaiting golfing privileges.

\* \* \* \* \*

**SECOND:** The following Item I is added to Article III:

- I. The term "Founder Member" as used in Items C and G of this Article III, and in Articles V, VI and VIII shall not include those Founder Members who have relinquished their voting rights as provided in the Bylaws (Article II, A., 4, Nonvoting Founder Membership) and have become Nonvoting Founder Members, but as used in the other provisions of these Articles, that term shall include Nonvoting Founder Members.

**THIRD:** The foregoing amendments were adopted by a vote of the members of the Corporation on September 28, 1998, the number of votes cast for the amendments having been sufficient for approval.
