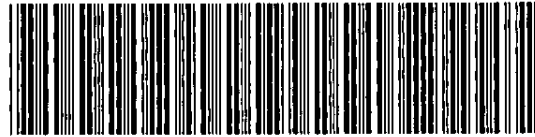

This is to certify that on the 20th day of March, 2012, the directors of the Fort Lauderdale Rescue Tabernacle, Inc., a corporation not for profit (organized pursuant to Articles of Incorporation filed in the Circuit Court of the Fifteenth Judicial Circuit of Florida, in and for Broward County, and approved by Order of said Court dated March 22, 1954, all of which were recorded in Official Records Book 121, Pages 479 through 483 of the Public Records of Broward County, Florida) at a meeting held at the Tabernacle pursuant to the Florida Statutes Section 607.181 and the directors of said non-profit corporation, did by unanimous approval of the directors in attendance amend the Articles of Incorporation of Fort Lauderdale Rescue Tabernacle, Inc., as follows:

1. Deleting the figure \$1,000,000.00 in Article IX as Amended on the 30th day of July, 1976, and substituting the figure \$1,500,000.
2. Remove Article X, which restricts the value of real estate owned by the corporation.

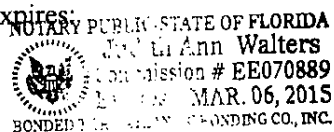
