ARTICLES OF AMENDMENT OF PENSACOLA CHRISTIAN COLLEGE, INC.

Article 5 of the Amended and Restated Articles of Incorporation of Pensacola Christian College Inc. is hereby amended to read:

5. <u>Purposes</u>. The purposes for which this Corporation is organized are the establishment and support of any religious, charitable, scientific, literary or educational activities, within the meaning of Section 501(c)(3) of the Internal Revenue Code, either directly or indirectly through its cooperation with public or private agencies having like purposes or objects, including, but not limited to the following:

To conduct any and all activities that will contribute to the general education and religious training of students, and in furtherance of the spread of Christianity. The organization shall endeavor to instruct students in the essentials of culture, giving special emphasis to the Christian view of life and the standard of ethics as set forth in the Holy Scriptures, and affirming basic truths of biblical Christianity including the following:

The Bible is the inspired Word of God and the Christian's final authority for faith and practice (II Timothy 3:16). The birth of Jesus Christ is evidence of His Deity, in that He was Virgin born and was God in the flesh (Matthew 1:20, I Timothy 3:16). The Blood of Jesus Christ, shed on Calvary, is the only Atonement for man's sin (I Peter 1:18-19, I John 1:9, John 14:6). The burial, bodily Resurrection of Jesus Christ from the tomb, and His ascension into Heaven. (I Corinthians 15:1-4). The Body of Christ, also called the Church, is composed of all born-again believers who have by faith accepted Jesus Christ as Savior (Ephesians 2:8-22, 3:1-21,4:4-16,5:23-32). The Blessed hope of the personal return of Jesus Christ back to earth. (Titus 2:13). The believers call is to a life of consecration which requires increasing in the knowledge of Christ and growing in grace (Colossians 1:10, II Peter 3:18, John 15:4-5). The will of God for all believers is to give evidence of sanctification to the world through being honorable in all relations with others (Romans 12:1-2, 1 Thessalonians 4:3, James 1:27). These Articles of Amendment were unanimously approved by the directors of the corporation by resolution set forth in its Minutes of Action dated and adopted as of November 3 2 2009. The not for profit corporation has no members entitled to vote on this amendment.

Except as amended hereby, the Amended and Restated Articles of Incorporation and the provisions thereof are ratified and confirmed, and shall remain in full force and effect.
