BAPTIST HOSPITAL OF MIAMI, INC: (a Not For Profit Corporation)

By majority vote of the Board of Directors and the Members of Baptist Hospital of Miami, Inc., at a meeting held on _________, 2011, at which a quorum was present, and by majority vote of the Board of Trustees of Baptist Health South Florida, Inc., at a meeting held on June 4, 2011, at which a quorum was present, the Board of Directors and Members of Baptist Hospital of Miami, Inc., and the Board of Trustees of Baptist Health South Florida, Inc., adopted the following amendments to the Articles of Incorporation of Baptist Hospital of Miami, Inc., with such amendments to be effective as of _________, 2011:

Article III (d) of the Articles of Incorporation is amended to read as follows:

"(d) <u>President of the Medical Staff</u>. The President of the Medical Staff of the Corporation (hereafter the "Medical Staff") shall be a Director while serving as President of the Medical Staff. If the President of the Medical Staff shall not agree or is unable to serve as a Director, then the vacancy shall not be filled until a new President of the Medical Staff is elected. If the President of the Medical Staff is employed by the Corporation or by Baptist Health South Florida, Inc. or any of its affiliates, then the President of the Medical Staff shall serve as a nonvoting member of the Board during such time as he or she is so employed."

These Articles of Amendment were duly adopted by the Board of Directors and Members of Baptist Hospital of Miami, Inc., on June 4, 2011, and by the Board of Trustees of Baptist Health South Florida, Inc., on June 4, 2011, and the number of votes cast for the Amendments by the Directors and Members of Baptist Hospital of Miami, Inc., and the Board of Trustees of Baptist Health South Florida, Inc., was sufficient for approval. The Amendments included in these Articles of Amendment have been adopted pursuant to Sections 617.1002 and 617.1006, Florida Statutes and there is no discrepancy between the Articles of Incorporation as previously filed and amended and the provisions of these Articles of Amendment other than the inclusion of the Amendments adopted pursuant to Sections 617.1002 and 617.1006, Florida Statutes.
