

FIRST AMENDMENT TO ARTICLES OF INCORPORATION
OF AZALEA PARK BAPTIST CHURCH

A meeting of the five-member Officers of Azalea Park Baptist Church, which operates under the bylaws of Azalea Park Baptist Church, a non-profit organization under the laws of the State of Florida, held the 25th day of February 2018, at which said meeting a quorum was present and acting throughout, the following resolutions were adopted:

The Title of the ARTICLES OF INCORPORATION shall be: ARTICLES OF INCORPORATION of the Azalea Park Baptist Church (omitting "of Orlando").

ARTICLE VII, # 2. shall be changed to omit "...and one-third of said Board shall be elected each year. No Deacon shall be eligible to succeed himself until after he has been out of office for a period of one year." The following shall be added: "In the absence of a qualified deacon, A deacon may succeed himself.

ARTICLE IX, line five "sitting in Church conference" shall be deleted and replaced with "in attendance, and no proxy voting shall be permitted."

ARTICLE X, line 2, "\$75,000" shall be replaced with "\$500,000."

ARTICLE XI shall be completely deleted.

The foregoing was adopted as the amended Articles of Incorporation of AZALEA PARK BAPTIST CHURCH, a corporation not for profit under the laws of the State of Florida, at a meeting of the officers on the 13th day of March 2018.
