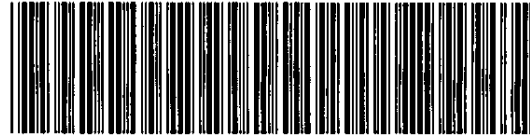

**Amend Article VI - Officers:** The business affairs of this corporation shall be managed by a Board of Trustees, whereas such management to be subject to the approval of the Church, and said board to be composed of not less than nine, and said Board of Trustees shall be elected from and by the membership of said corporation. The term of membership of Trustees shall be for life, or for such other length of time, not less than one year, as the membership of said corporation may provide by its by-laws. The said Board of Trustees shall appoint from its own membership a Chairman, Vice-chairman, and Secretary, and the term of said officers shall be for one year. All legal instruments of the corporation shall be signed by said Chairman or Vice-Chairman, sealed with the corporate seal, and attested by said Secretary, or in such other manner as may be authorized by law. All elections to membership on said Board of Trustees shall be by majority vote of the members of said corporation present at any Trustees meeting of said corporation. The addition to said Board of Trustees of said corporation shall have a Pastor, Church Clerk, Treasurer, Sunday School Superintendent, R.T.U., Board of Deacons, and such other officers as may be necessary, and such officers may be elected by a majority vote of the corporation members present at any business meeting of said corporation for such term as the corporation may provide by its by-laws.

**Add Article XII – Dissolution of Assets:** After this corporation has elected to be a 501(c)(3) corporation of the Internal Revenue Code, none of the directors of this corporation, without the written consent of all the directors of this corporation shall take any action, or make any transfer or other disposition of the assets of the corporation. Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and the obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under section 501 (c)(3) of the Internal Revenue Code, which is organized and operated exclusively for exempt purposes, such as religious, charitable, and/or educational.
