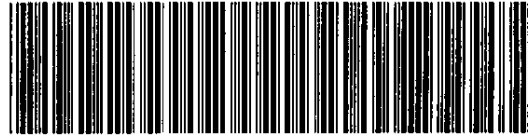



Pursuant to Sections 617.1001 and 617.1006, Florida Statutes (2009), UNIVERSITY BOULEVARD CHAPEL OF THE CHURCH OF GOD AT JACKSONVILLE, FLORIDA, INC., a Florida corporation not-for-profit (hereinafter called the "Corporation"), hereby certifies as follows:

FIRST: The name of the Corporation is UNIVERSITY BOULEVARD CHAPEL OF THE CHURCH OF GOD AT JACKSONVILLE, FLORIDA, INC., a non-profit corporation.

SECOND: The members of the Corporation, acting pursuant to Section 617.1002, Florida Statutes (2009) and in accordance with the requirements of Article X of the Amended and Restated Articles of Incorporation filed on March 28, 1994, after proper notice to the members and by vote of more than three-fourths (3/4ths) of the members present and voting on the proposal, have approved the proposed name change and agreed to delete the existing Article I of the Restated Articles of Incorporation in its entirety and insert in lieu thereof the following:

"ARTICLE I"
