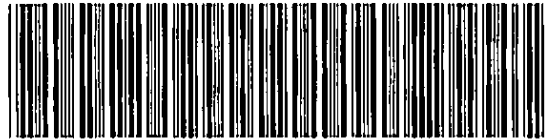

Pursuant to the provisions of sections 617.1001 and 617.1006, Florida Statutes (2018), NEW JOURNEY CHURCH OF JACKSONVILLE, INC., a Florida corporation not-for-profit (hereinafter called the "Corporation"), hereby certifies and adopts the following amendments to its Article of Incorporation:

A. The members of the Corporation, acting pursuant to the provisions of section 617.1002, Florida Statutes (2018), and in accordance with the requirements of Article X of the Amended and Restated Articles of Incorporation filed on March 28, 1994, after proper notice to the members and by vote of more than three-fourths (3/4ths) of the members present and voting on the proposal, have approved the following amendments.

B. It is agreed that the existing Article I of the Amended and Restated Articles of Incorporation filed on March 28, 1994, which was amended on July 6, 2010, is to be deleted in its entirety and the following inserted in lieu thereof:

**"ARTICLE I"**

**"Name"**

"The name of this corporation is: BRIDGES COMMUNITY CHURCH, INC."

C. The new principal office address shall be 9451 Regency Square Boulevard, Jacksonville, Florida 32225.

D. The new mailing address shall be P.O. Box 19334, Jacksonville, Florida 32245.

E. The foregoing amendment to the Articles of Incorporation of the Corporation shall become effective upon the filing of these Articles of Amendment with the Secretary of State of the State of Florida.

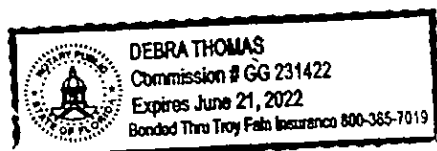
