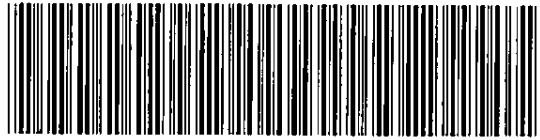

ARTICLES OF INCORPORATION

OF

FOREST CITY BAPTIST CHURCH HOLDING COMPANY, INCORPORATED

A Corporation Not For Profit

We, the undersigned members of FOREST CITY BAPTIST CHURCH, ROUTE 2, MAITLAND, FLORIDA, hereby form ourselves and our successors into a corporation not for profit under the corporate name of FOREST CITY BAPTIST CHURCH HOLDING COMPANY, INC., Route 2, Maitland, Florida, and hereby adopt the following articles of incorporation:

ARTICLE I.

The name of this corporation shall be FOREST CITY BAPTIST CHURCH HOLDING COMPANY, INC., and it is located at WEST LAKE BRANTLEY ROAD, ROUTE 2, SEMINOLE COUNTY, MAITLAND, FLORIDA.

ARTICLE II.

1. The general nature and object of this corporation is:

a. To purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use or otherwise deal in and with real and personal property or any interest therein wherever situated; and,

b. To build, erect, construct, provide for, maintain and equip suitable buildings, churches, houses, etc. for the benefit, use and occupation of said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, its members and congregation, in maintaining and fostering public worship, and the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and for all other meetings and purposes of the said Church, its members and congregation; and,



c. To build, construct, erect, maintain, and equip schools, mission stations and mission churches, pastors' homes and such other houses or equipment as the Church may desire for carrying on its work; and,

d. To conduct its affairs, carry on its operations and exercise the powers granted by this charter in any state, territory, district or possession of the United States or foreign country; and,

e. To receive, administer, disburse and invest gifts, devises and bequests by or from any persons or corporations; and,

f. To issue bonds, notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust or otherwise.

2. This corporation is organized primarily for the purpose of:

a. Holding the title to such property or properties as the said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, shall, from time to time, purchase or acquire; and,

b. To have power, from time to time, to make such contracts and to do such things as shall be authorized and directed by members of said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida.

ARTICLE III.

The membership of this corporation shall consist of three members of the FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, in good and regular standing of said Church, to be elected by the said Church at its regular business meeting in September of each year, or as soon thereafter as convenient, to serve for a period of one year, or until their successors are elected and qualified.

If any member ceases to be a member of said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, in good and regular standing, he shall cease to be a member of this corporation, and the vacancy may be filled by the members of said Church at any regular business meeting of said Church, or at a special meeting called for that purpose.

ARTICLE IV.

The term for which this corporation is to exist is to be perpetual.

ARTICLE V.

The names and residences of the subscribers to this corporation are as follow:

ARTICLE VI.

The officers who are to manage the affairs of this corporation shall be a president, a secretary, and a treasurer, to be elected by the FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, at its regular September business meeting each year, or as soon thereafter as convenient, to serve for a period of one year or until their successors are elected and qualified. Should a vacancy occur, said vacancy may be filled by the members of said Church at any regular business meeting of said Church, or at a special meeting called for that purpose.

ARTICLE VII.

The names of the officers who are to manage the affairs of this corporation until their successors are elected and qualified shall be as follow:

Mr. Carl M. Schoelles - PRESIDENT
Mr. Sterling ^{W.} Copeland - SECRETARY
Mr. Charles L. Jackson - TREASURER

The residences of the officers are listed in Article V, above.

ARTICLE VIII.

The officers of this corporation listed in Article VII above are to serve as trustees of this corporation until replaced by their successors, at which time their successors duly elected and qualified, shall become trustees of this corporation. The names and residences of the trustees are the same as those listed in Article V, above.

ARTICLE IX.

The by-laws of this corporation shall be made, altered or rescinded by the corporation at any regular or special meeting duly and legally called, but any alterations or amendments of said by-laws shall only be made by a two-thirds vote of all the members of the corporation.

ARTICLE X.

Any amendments to the articles of incorporation may be proposed by any member of the corporation and adopted at any regular or special meeting of FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, duly and legally called; but, any alteration or amendment of said articles of incorporation shall only be made by a two-thirds vote of all members, present and voting, of said Church.

ARTICLE XI.

This corporation shall have no power to mortgage, sell, encumber, deed or otherwise dispose of any property without the written consent and direction of the said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, evidenced by resolution of said Church duly passed.

The highest amount of indebtedness or liability to which this corporation may, at any time, subject itself shall be authorized and directed by members of said church, evidenced by resolution, duly passed.

This corporation shall have power to bond or mortgage its property in a sum not to exceed that authorized and directed by members of said FOREST CITY BAPTIST CHURCH, Route 2, Maitland, Florida, evidenced by resolution and duly passed.

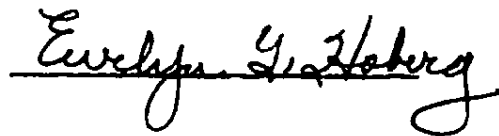
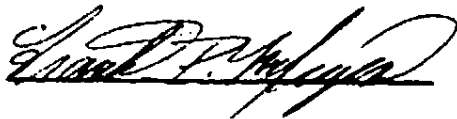

MINUTES OF THE REGULAR BUSINESS MEETING, DECEMBER 9, 1979
FOREST CITY BAPTIST CHURCH, FOREST CITY, FLA.

The meeting was called to order by Pastor Meyers and a quorum was found to be present.

Printed copies of minutes of the previous meeting were distributed and read. There being no additions or corrections, the minutes were approved as read.

TREASURER'S REPORT: Given by Audrey McDorman (copy attached). This showed a balance in the organ fund of \$3899.91; certificate of deposit, \$1,615.80; Library Fund, \$200.90; Benevolent Fund, \$59.83; average weekly tithes and offerings, \$469.14. Motion was made, seconded and carried that this report be accepted as rendered.

SIGN COMMITTEE: To be given at a later date.

FLOWER COMMITTEE: given by Evelyn Hoberg - no unusual developments.

ORGAN COMMITTEE: given by Evelyn Hoberg who said the organ being used is well liked, but we are having it checked by Stroeps before actually purchasing.

NURSERY: No report.

NOMINATING COMMITTEE: given by Mr. Hoberg. Moved that Rev. Meyers and Hazel Norman be elected as teachers in the Sunday School. Rev. Meyers for the college and career class and Hazel Norman for the Middle school class. Motion made, seconded and carried. Further recommendations: 1. Pat Meyers be elected as assistant clerk. Put in the form of a motion, it was seconded and carried. 2. Historian, Mrs. Janet Hartman. Motion made, seconded and carried. 3. For trustee, Mr. Al Haggard. Motion made, seconded and carried.

SUNDAY SCHOOL REPORT: given by Mr. Belcher revealed the following: enrollment, 89, average members present, 55; average visitors, 4; average offering \$424.71.

DEACONS' REPORT: given by Walter Hoberg, who stated that most of their activities will be outlined under new business.

Pastor Meyers advised that Alice Tague had donated a diamond pendant to the church, which was appraised at \$9,288.00. After exhaustive investigation and trying to sell through advertising, contacting dealers both locally and otherwise, it was found the highest price that could be obtained was \$2,500.00. Most offered only \$1800.00. Therefore, the pendant was sold for \$2,500.00. Mrs. Tague has stipulated that the purchase of the organ and any expense involved therewith is to be taken care of first. This to include a scheme to project the carillon chimes to the outside of the sanctuary for the benefit of the entire community. After that, it is hoped it will cover the expense of a spire for the front of the church. If any remaining, this is to be used for the improvement of the education building.

TRUSTEES' REPORT: given by Mr. Bencher, who advised that they had been looking into the expense of the spire best suited to our needs--one to be illuminated from the inside. He showed pictures of what they have in mind. Price, delivered here, \$1,569.00. He recommended that we purchase this one. We did have access to a used one, but it was thought it was not the type best suited to our needs. Motion made to purchase the one recommended by the trustees, which was seconded and carried. It was noted that this spire could be installed in such a manner as to allow for the projection of the carillon music through it. This to be done in honor of Alice Tague who has made all this possible. Motion made, seconded and carried that this be done.

DAY CARE CENTER: We were advised that the Day Care Center is in the process of moving and Mr. Belcher has requested a "kick-off" workday the first Saturday in January, 1980. Work is needed on the bathrooms. Nursery equipment is in such need, specifically cribs for bed tables. Donations from members will be appreciated.

YOUTH COUNCIL: No report

SECRETARY'S REPORT: A letter was read from Mr. Gene Groves tendering his resignation as music director since he is accepting a similar job in the First Baptist Church in Helena, Montana where he is now living. Motion made to accept his resignation with regrets. Motion seconded and carried. Also letters received from the following: Ballast Point Baptist Church, Tampa, Florida, recommending Richard, Audrey and Wendy McDorman to our fellowship; and a letter from Trinity Baptist Church, Apopka, Florida, recommending Mrs. Patti Shepherd to our fellowship.

NEW BUSINESS: Motion made to have Evelyn Hoberg's name added to the list of those who have access to the safety deposit box at the State Bank of Forest City, Florida. Motion seconded and carried.

NAME CHANGE: The pastor advised that we had written to Tallahassee to find out what is involved in changing the name of our church from Forest City Baptist Church to The First Baptist Church of Forest City and had been advised that the officers of the church must sign a statement that we do want this change and telling the new name, then proceed according to the charter. Cost involved around \$20.00. The charter is in the safety deposit box at the bank. Motion made and seconded that we change the name as shown above. Motion carried.

Motion was made and seconded to adjourn. Motion carried and the meeting adjourned with prayer.

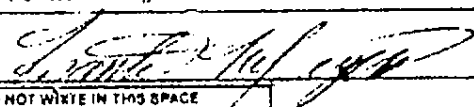

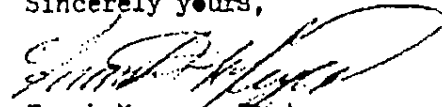

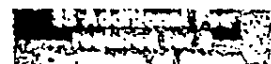
