THIRD AMENDED AND RESTATED ARTICLES OF INCORPORATION

The Amended and Restated Articles of Incorporation of this Florida non-profit corporation filed with the Florida Secretary of State on December 4, 1997 are hereby amended and restated to read in their entirety as follows:

ARTICLE I. Name

The corporate name for this corporation is Rotary Club of Jacksonville, Florida, Inc.

ARTICLE II Addresses

The street address of the principal office of the Corporation is 12020 Winstead Road. Jacksonville, Florida 32220. The mailing address of the Corporation is Post Office Box 37028. Jacksonville, Florida 32236.

ARTICLE III Purposes

The purpose shall be to engage in any lawful activity to further the Object of Rotary. The Object of Rotary ("Object of Rotary") is to encourage and foster the ideal of service as a basis of wor enterprise and, in particular, to encourage and foster:

- 1. The development of acquaintance as an opportunity of service;
- 2. High ethical standards in business and professions; the recognition of worthiness of all useful occupations; and the dignifying by each Rotarian of such Rotarian's occupation as an opportunity to serve society;
- 3. The application of the ideal of service by every Rotarian to their personal, business and community life:
- 4. The advancement of international understanding, good will, and peace through a world fellowship of business and professional people united in the ideal of service.

ARTICLE IV Election of Directors

The number of directors and the method of election of directors shall be set forth in the Constitution and/or Bylaws of the Corporation, but the number shall not be less than three.

ARTICLE V Corporate Powers and Period of Existence

This Corporation is a non-profit corporation with perpetual existence and with all the rights, powers and privileges permitted under the Law of the State of Florida.

ARTICLE VI Registered Office and Registered Agent.

The Corporation's registered office is: 1301 Riverplace Blvd., Suite 1500, Jacksonville, FL 32207. The name of the Corporation's registered agent at that address is: **E. Allen Hieb**.

ARTICLE VII Amendments to the Articles

Amendments proposed to these Articles may be adopted at a regular meeting of the members of the Corporation, a quorum being present, by two thirds (2/3) vote of the members present, provided that notice of such proposed amendment has been given to each member at least ten (10) days before such meeting.

ARTICLE VIII Constitution

This Corporation shall have the authority to adopt such Constitution, and amendments, not inconsistent with the purposes stated in these Articles or with the Constitution and Bylaws of Rotary International ("RI") (and the rules of procedure for an area administration where established). The method of adopting the Constitution of this Corporation, and amendments, shall be set forth in said Constitution.

ARTICLE IX Bylaws

This Corporation shall have the authority to adopt Bylaws, and amendments, not inconsistent with these Articles or with the Constitution of the Corporation, or with the Constitution and Bylaws of RI (and the rules of procedure for an area administration where established). They method of adopting the Bylaws of this Corporation, and amendments, shall be set forth in sale Bylaws.

ARTICLE X Territorial Limits

The territorial limits of this Corporation for purposes of determining qualifications for membership shall be the City of Jacksonville, Florida and the surrounding area.

ARTICLE XI Membership

Membership provisions shall be set forth in the Constitution and/or Bylaws of the Corporation.
