

3. The effective date of the Articles of Dissolution shall be March 30, 2011.



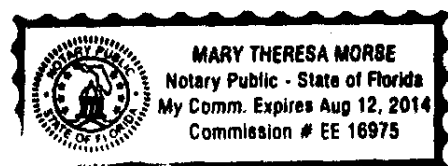
