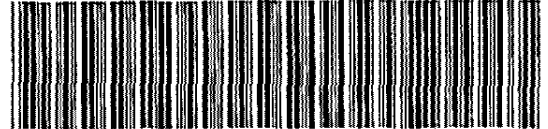

**RESTATEMENT
of the
ARTICLES OF INCORPORATION
of**

FORT LAUDERDALE FIREMEN'S BENEVOLENT ASSOCIATION, INC.

Pursuant to the provisions of Sections 617.1007 of the Florida Statutes, the undersigned Florida Not For Profit Corporation restates its articles of incorporation to read as follows:

**ARTICLE I
Name**

The name of the Corporation is Fort Lauderdale FireFighter's Benevolent Association, Inc.

**ARTICLE II
Principal Office**

The Corporation shall be located in the City of Fort Lauderdale, Broward County, Florida. The principal place of business and the mailing address of the Corporation is 309 SW 26th Street, Fort Lauderdale, Florida 33315.

**ARTICLE III
Purpose and Intent**

This Corporation shall have for its purpose(s): to protect and promote the interest of the members by bargaining collectively with their employers to secure better working conditions, to better the overall welfare of its members, to improve the grade of their products, to develop of a higher degree of efficiency in the Fort Lauderdale Fire Department, and to promote confidence and cooperation between its members and the public.

**ARTICLE IV
Earnings**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE IV
Management

The Corporation shall be governed by the following Officers: a President, a Vice President, a Secretary, a Treasurer; and a Board of Directors consisting of Seven (7) members who are as follows: President, Vice President, Secretary, Treasurer and Three (3) Member Directors. The duties and method of election of the Officers and Directors of the Corporation shall be stated in the Bylaws of said Corporation.

ARTICLE V
Registered Agent

The name and address of current registered agent of the Corporation is on file with State of Florida, Division of Corporations.


ARTICLE VI

This Corporation shall have perpetual existence.
