A RESOLUTION OF THE BAY COUNTY PUBLIC LIBRARY ASSOCIATION, INC. ADOPTING A PLAN OF DISTRIBUTION OF ASSETS; DISSOLVING THE CORPORATION; AND SETTING AN EFFECTIVE DATE OF DISSOLUTION.

WHEREAS, for over forty-seven years, the Bay County Library Public Library Association, Inc. (the "Regional Library") has provided and administered public library services for the citizens of Bay County and the surrounding areas;

WHEREAS, on December 18, 2006, the Board of Bay County Commissioners terminated its agreement with the Regional Library to provide and administer library services. Such termination was effective April 1, 2007;

WHEREAS, on March 20, 2007, the Regional Library and Bay County entered into an agreement to transfer the assets and employees of the Regional Library to Bay County (the "Transfer Agreement");

WHEREAS, in the Transfer Agreement, the Regional Library stated it "intend[ed] to dissolve and wind up its affairs no later than September 30, 2007," and agreed to distribute any unencumbered cash remaining at dissolution to benefit the Bay County Library; and

WHEREAS, the Regional Library now desires to adopt a formal plan of dissolution, distribute the remaining assets of the corporation in accordance with the adopted plan, and dissolve the corporation.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Directors of the Regional Library that the following plan of dissolution is hereby adopted:

(a) All liabilities and obligations of the corporation have be paid and discharged, except for <u>Five Thousand Dollars</u> (\$5,000.00) which shall be kept in escrow by Harrison, Sale, McCloy, Duncan & Jackson, Chtd. for the payment of one remaining unemployment compensation claim or any other unexpected liabilities. If a reimbursement request from the State of Florida or any other person is not received by <u>March 25, 2008</u>, the reserve amount shall be distributed by the escrow agent in accordance with paragraph (c) below.

- (b) There are no remaining assets which have been held by the corporation that require return, transfer, or conveyance upon dissolution.
- (c) Any remaining unencumbered cash, including unspent reserves remaining at dissolution, shall be distributed to benefit the Bay County Library as follows:
 - \$20,000.00 to the Friends of The Bay County Public Libraries, Inc.
 - All remaining funds, including any remaining escrow amount, to the Bay County Public Library Foundation, Inc.

BE IT FURTHER RESOLVED by the Board of Directors of the Regional Library that the corporation shall dissolve no later than November 30, 2007.

BE IT FURTHER RESOLVED by the Board of Directors of the Regional Library that the President of the Regional Library or the Acting Director of Libraries is authorized to execute all documents or to take any action necessary or desirable to implement this resolution.
