

# ARTICLES OF INCORPORATION OF NEW COLLEGE FOUNDATION, INC.

## Amendments to the Articles of Incorporation New College Foundation, Incorporated

(Revised changes as passed by the New College Foundation Board of Trustees at its November 3, 2006 Board meeting)

#### ARTICLE II.

The specific purposes for which this Corporation is organized are:

- (a) To exist and operate solely for scientific, educational, religious, and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 as amended ("Code").
- (b) To operate without regard to race, age, religion, sex, sexual orientation, or national origin.
- (c) To be organized and operated as a University direct-support organization as defined in Section 1004.28, *Florida Statutes*, as may be amended or supplemented.
- (d) To receive, hold, invest, and administer property and to make expenditures to or for the exclusive benefit of New College of Florida, a member of the state university system of the State of Florida.
- (e) To exercise all the powers enumerated in Chapter 617, Florida Statutes, as it now exists or is subsequently amended or superseded, and to do and perform such acts and to have such powers as shall be desirable and necessary in furtherance of any of the purposes enumerated herein which are not in derogation of the laws of the State of Florida.

#### ARTICLE III.

The Corporation shall have and exercise all powers of a corporation not for profit as the same now exist or hereinafter exist under the laws of the State of Florida. No part of the assets, income, or profits of the Corporation shall be distributable to, or inure to the benefit of, directors or officers or any private individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation to its employees for services rendered and to make payments and distributions in the furtherance of the purposes set forth herein, including supplementing or paying salaries of employees of New College of Florida and providing student financial aid to students of New College of Florida. Notwithstanding

any other provision hereof, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income taxation under Section 501 (c)(3) of the Code or by an organization, contributions to which are deductible under Section 170 of the Code.

#### ARTICLE VI.

The Corporation shall have no members.

#### ARTICLE VII.

The Board of Trustees of this Corporation shall consist of not less than twelve persons, nor more than thirty-six persons. Members of the Board of Trustees shall be selected as provided in the By-laws. Board Officers and Corporate Officers shall be established in the By-laws and shall be selected as provided in the By-laws.

#### ARTICLE X.

In order to carry out the purpose of this Corporation the Board of Trustees of this Corporation shall impose and adopt By-laws regulating the conduct of its affairs and its operations. The By-laws may be amended by a majority vote of the Trustees present at any duly called and constituted meeting of the Board of Trustees.
