ARTICLES OF INCORPORATION of the WESTVIEW BAPTIST CHURCH, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation:

<u>ARTICLE I</u>

NAME

The name of this corporation shall be WESTVIEW BAPTIST CHURCH, INC., and its principal place of business and place of worship shall be at 13301 Northwest 24th Avenue, in the County of Dade and State of Florida.

ARTICLE II

PURPOSE

The general purposes, and objects of this corporation, shall be to conduct for religious worship and instruction, churches, schools, parsonages, and other institutions connected therewith of a religious, educational, charitable and benevolent character, to the end that its own members and others may be generally instructed and guided concerning those Articles of Faith. Further, to advance spiritual growth and enlightenment, moral and personal purity, among its own membership and the people of the community, in which it is located; also to educate, prepare, and ordain Christian men for the ministry of the Gospel of Jesus Christ; and for the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease, and improve real estate and personal property for itself and others, either as Trustee or otherwise.

ARTICLE III

USE OF INCOME

All revenue, profit, income and money received from the conduct of such business or enterprise is to be used and employed in religious, educational, charitable, benevolent, and missionary work and not for profit, for the benefit of the members of said corporation, either individually or collectively.

ARTICLEIV

POWERS

Said corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of the corporation, and in general to possess all the rights, privileges and immunities, and enjoy all the benefits granted to corporations of similar character, under the law of the State of Florida.

<u>ARTICLE V</u>

OUALIFICATIONS FOR MEMBERSHIP

Every person who believes in repentance toward God, and faith in Jesus Christ, as Savior and Lord, and who is willing to confess to Him, publicly as Lord and King, and follow Him in baptism by immersion, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in this corporation.

ADMISSION TO MEMBERSHIP

The manner of admission to membership in said corporation shall be by letter of satisfaction from other churches, of like faith and order, by Christian fellowship, Christian experience, and profession of faith as hereinabove provided in Article V.

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VIII

MANAGEMENT OF AFFAIRS

- (1) The business of this Corporation shall be managed by the Pastor.
- (2) The Pastor (or in his absence or incapacity, the Chairman of Deacons, then Church Clerk/Secretary), shall be the Chief Executive Officer of the Corporation, and as such officer, shall have authority to sign and execute in their official capacity, all deeds, contracts, mortgages, trust deeds, notes, other legal documents, and papers for said Church Corporation.

ARTICLE IX

DEACONS

- (1) Deacons shall be appointed by the Pastor of said Corporation.
- (2) There shall be as many Deacons, that the Pastor deems necessary.
- (3) They shall be appointed upon the basis of qualifications, as set forth in the New Testament, of the Bible. The Deacons will serve as long, as they're of a sound mind and in good health.

- (1) The Wednesday night following the first Sunday in each month, shall be set apart as a church conference by the membership of the church corporation, for receiving reports of the committees and departments, of the Church. Planning the program and activities of the Church, acting upon requests for letters of dismissal, and for the transaction of such other business, as may be proper.
- (2) The annual business meeting, of the Church membership, shall be held on Wednesday, following the first Sunday in October of each year, at which the annual reports will be read.
- (3) All heads of departments, such as Sunday School Superintendent, Brotherhood President, Missionary Union President, Hospitality Ministry, shall be appointed, by the Pastor, at the regular monthly meeting in June.

ARTICLE XI

(1) The By-Laws of the Church and these Articles of Incorporation may be altered, changed, or amended by the members of the church, at any regular business meeting called by the Pastor (or in his absence or incapacity, the Chairman of Deacons, then Church Clerk/Secretary), for that purpose, provided that proper notice, has been given at a previous regular business meeting, and provided also, that such proposed changes have been submitted to the Pastor, for his approval, prior to bringing it to the Church, for consideration. The Chairman of Deacons and/or Church Clerk/Secretary may express approval or disapproval, but the final action, thereon is subject to the vote of the membership of the Church. All such proposed alterations, changes or amendments of the By-Laws or Articles of
