The meeting was called to order at 7:15 p.m., and it was reported that a quorum was present.

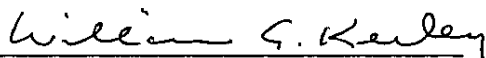
The members present at a meeting on March 21, 2007, had requested to have the by-laws changed in Article III, Section 3, to require a vote of 75% of members present at a meeting to call a new pastor, rather than the majority present, as is in the records now.

The vote was announced at the Wednesday evening church service on March 18, 2007, then again, at the Sunday morning and Sunday evening church services on March 25, 2007.

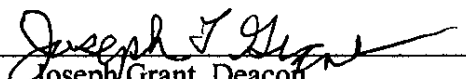
The meeting on March 28, 2007, was called to order by William Kerley. The Articles of Incorporation were read, and the proposed change was read. Motion to change the Articles of Incorporation was made by Joe Sills and seconded by Bob Smith. After discussion, the motion was carried to take a vote on the change. The vote was unanimous to ~~change~~ the Articles of Incorporation, Article III, Section 3:

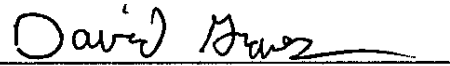
From: It is the responsibility of the membership to be present at all services. If business meetings are called, the majority present at the time of the meeting will rule.

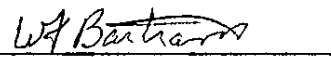
