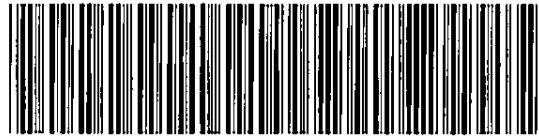

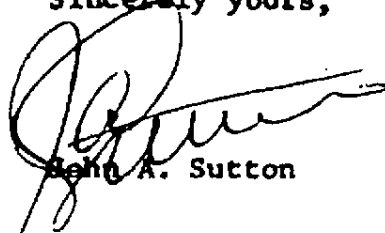

ARTICLES OF INCORPORATION

OF

THE PINE HILLS CHRISTIAN CHURCH, INC., ORLANDO, FLORIDA

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, (Florida Statutes, Chap. 617), and respectfully petition the proper State for approval of such incorporation under the following proposed Articles of Incorporation:

ARTICLE I - NAME AND LOCATION

The organizers began holding services December 30, 1959 and organized as a church April 19, 1960. The name of this corporation shall be THE PINE HILLS CHRISTIAN CHURCH, INC., and its location shall be in the general Pine Hills area, Orlando, County of Orange and State of Florida.

ARTICLE II - PURPOSE

The purpose of this corporation shall be to maintain a Christian Church patterned after the Church set forth in the New Testament and to promote the Christian religion throughout the world, and, more particularly to own and maintain facilities for public worship and to provide for worship and religious instruction and other Christian activities. To this end it shall have the following powers:

- A. To own, buy, sell, exchange, convey, and lease real estate where the same shall be deemed necessary or desirable for the furtherance of the Christian work of the Church;
- B. To obtain loans upon said real estate, or other security and mortgage and purchase such property and loans and all interests and claims regarding the same;
- C. To insure against loss by fire and other casualties;
- D. To establish and maintain chapels for religious services;
- E. To receive and utilize gifts and bequests for the furtherance of the objectives of this corporation;

~~ARTICLE III - AUTHORITY AND APOLOGY~~

This corporation recognizes the Bible as the Word of God and the New Testament as its authority in matters pertaining to the Church. It declares itself to be a free and autonomous body, claiming the right of free government and recognizing no outside religious authority or control.

ARTICLE IV - MEMBERSHIP

SECTION 1 - Membership shall consist of those people desiring membership who have complied with the following terms as required by New Testament teaching and example:

- A. Belief in Jesus of Nazareth as the Christ, the Son of God, and open acknowledgment thereof;
- B. Repentance, the decision to accept Jesus Christ as the Lord of one's life and to obey His revealed will to the best of one's ability;
- C. Baptism, immersion in water in obedience to Jesus Christ.

SECTION 2 - Any person may become a member of this Church upon his statement that he has complied with the terms of Section 1 of this Article.

SECTION 3 - Suspension of membership may result from conduct unbecoming a Christian, as specified in the New Testament, but only after every effort possible for reconciliation has been made.

ARTICLE V - TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual.

ARTICLE VI - GOVERNMENT

Until such time as the congregation deems it advisable to elect elders and deacons, the government of the Church shall be handled by regular meetings of the membership, with the assistance of an executive committee chosen by the congregation to carry out its wishes. The executive committee shall consist of at least four men and the minister. This committee shall elect from its own number a chairman, secretary, treasurer, and such other officers as deemed

expedient; and may appoint members of the Church to various other positions in the Church. The executive committee and all officers shall serve the calendar year or until their successors have been elected.

SECTION 1 - CHURCH BOARD.

When the congregation deems it advisable, it shall elect elders and deacons, who, along with the minister, shall compose the governing body known as the CHURCH BOARD. The number, tenure, qualifications and duties of the elders, deacons and minister shall be enumerated in the By-Laws.

The church board shall meet regularly to conduct the business affairs of the church. It shall have the privilege of seeking congregational action on any matter, and shall be required to seek congregational action on the following matters:

- A. The calling or releasing of a minister;
- B. The acquiring or disposing of real estate;
- C. Any major change in policy.

The church board shall be presided over by the chairman of the elders and shall elect from its own members a church treasurer, financial secretary, church secretary and any other officers that it shall deem advisable to carry out its functions. These said officers shall serve for a period of one calendar year or until their respective successors are elected.

The board shall determine rules for its own proceedings and for the conducting of church elections. All church elections shall be by secret ballot.

Any vacancies occurring among the church officers may be filled by the church board until the ensuing election.

SECTION 2 - ACTIVE MEMBERSHIP AND VOTING PRIVILEGES.

Active membership and voting privileges shall be accorded to all members who have shown by their attendance and service an

active interest during the six months period immediately preceding any voting issue or during the period of membership if such is less than six months. The exception to this rule shall be in the case of illness or other unavoidable causes which result in inattendance or lack of service. Any question regarding the qualification of a member for voting shall be determined by the elders under the provisions of this section.

ARTICLE VII - BUSINESS MEETINGS

SECTION 1 - ANNUAL MEETING.

An annual meeting of the membership of the church for the transaction of business shall be held in January at a time determined by the church board. Notice of such meeting shall be by public announcement at two Sunday morning services immediately preceding such meetings.

SECTION 2 - SPECIAL MEETINGS.

A special meeting for the transaction of church business may be held at the call of the chairman of the board or upon written request to the board of ten per cent (10%) of the active members of the church. The call shall be by public announcement at two Sunday morning services immediately preceding the meeting and such announcement shall state the purpose of the meeting.

SECTION 3 - QUORUM.

At all business meetings of the congregation, a quorum shall consist of twenty per cent (20%) of the resident membership.

ARTICLE VIII - BY-LAWS

The By-Laws of this church are to be made, altered or rescinded by the executive committee or the church board at any business meeting, provided, however, that said By-Laws or the modification thereof shall not become effective unless the same shall be approved at any business meeting of the church by a two-thirds vote of the active members present and voting after at least two weeks notice has been given to the members of the church.

Regular Sunday morning service immediately preceding the date of the business meeting at which said By-Laws or their modification are to be approved.

ARTICLE IX - AMENDMENTS

These Articles of Incorporation may be amended at any business meeting of the Church by a two-thirds vote of the active members present and voting, provided that notice of the proposed amendment or amendments has or have been read at each regular Sunday morning service for four consecutive Sundays immediately preceding the date on which the vote is taken.

EXCEPTION: Article III and Section 1 of Article IV of the Articles of Incorporation cannot be amended. Any attempt to amend these articles violates the intent of the founders and those attempting such action shall forfeit their right of membership and any claim to the property of the Pine Hills Christian Church, Inc.

ARTICLE X - INITIAL SUBSCRIBERS

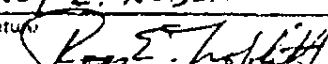
