ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FLORIDA NOT FOR PROFIT CORPORATION

The following Articles of Amendment to the Articles of Incorporation for the below described Florida Not For Profit Corporation are hereby filed pursuant to Florida Statutes Section 617.1504.

- 1. Name of Corporation: ST. PETERSBURG ASSOCIATION OF THE DEAF, INC.
- 2. Incorporated under laws of: Florida
- -3. Date authorized to conduct affairs in Florida: February 28, 1961
- 4. Document number: 702075
- 5. The Articles of Incorporation of the above described Corporation are hereby amended as follows:
- a.) Notwithstanding any other provision of these articles, said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify-as-exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b.) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
