ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF MEASE MANOR, INC.

7979 ATT 10 PH 1:27

These Articles of Amendment of Articles of Incorporation of Mease Manor, Inc., a Florida not-for-profit corporation (the "Corporation"), are adopted and filed pursuant to the provisions of Sections 617.1001, 617.1002, and 617.1006, Florida Statutes, as amended.

- 1. The name of the Corporation is Mease Manor, Inc., but the Corporation's name is changed pursuant to these Articles of Amendment. The Corporation's Document Number is 702243. The Corporation's Articles of Incorporation were originally filed on April 7, 1961, and were previously amended and restated on September 26, 1988, amended on April 15, 1992, amended and restated on January 31, 2002 and September 6, 2011, and amended on January 2, 2019.
- 2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE I Name

The name of the Corporation is **MEASE LIFE**, **INC**. (hereinafter, the "Corporation").

- 3. The Corporation has no members. The amendment set forth in these Articles of Amendment was duly authorized by the Board of Trustees of the Corporation on February 27, 2020, in accordance with Section 617.1002, Florida Statutes. The vote of the Board of Trustees, being unanimous, was sufficient for approval.
- 4. In accordance with Article XI of the Articles of Incorporation of the Corporation, the amendment set forth in these Articles of Amendment was duly authorized by the Board of Trustees on February 27, 2020, following consideration of a rebranding initiative presented to the Board by Spectrum Marketing. The vote of the Board of Trustees of the Corporation, being unanimous, was sufficient for approval.
- 5. The amendment set forth above shall be effective upon the filing of these Articles of Amendment with the Florida Secretary of State.
