ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of

TRUSTEE CORPORATION OF SANTA CLARA BAPTIST CHURCH, INCORPORATED

Pursuant to the provision of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Amendment adopted: ARTICLE I, NAME AND LOCATION

The Articles of Incorporation are amended to change the name of the corporation by striking from Article I, first sentence, the words "TRUSTEE CORPORATION OF THE SANTA CLARA BAPTIST, INCORPORATED," and insert in lieu thereof the following:

The name of the corporation shall be SANTA CLARA BAPTIST CHURCH, INCORPORATED, and it shall be commonly known and referred to as the "Corporate Body," as distinguished from the Santa Clara Baptist Church, the unincorporated body, hereinafter referred to as the "Church." The place where said corporation shall be located is in Quincy, of the County of Gadsden, and the State of Florida.

**SECOND:** The date of adoption of the amendment was May 16, 2001

**THIRD:** Adoption of Amendment

The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
