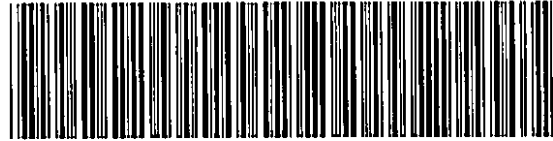

I. The name of this corporation shall be The Art Spirit Venice-Nokomis Art Association, Inc., and the place where it is to be located is Venice or Nokomis (no land yet) Sarasota County, Florida.

II. The general nature of the object of the corporation shall be non-profit character, for educational and cultural purposes and to aid in whatever may tend to stimulate and encourage the appreciation of art.

III. The qualification of members and the manner of their admission shall be as follows: The membership shall include artists and laymen (non-artists). The term of membership shall be one year, dated from January 1st of each year. Admission shall be granted to all persons approved by the Board of Directors and to all artists approved by the Artist Committee upon the payment of dues.

IV. The term for which said corporation is to exist shall be perpetual.

The affairs of the corporation are to be managed by a President - Vice President - Recording Secretary - Corresponding Secretary - Treasurer - and eleven active members who, with the officers named, shall constitute the Board of Directors. The Directors shall be elected by ballot for term of one year at the Annual Meeting in April each year, as specifically fixed each year by resolution of the Executive Committee.
