AMENDMENT TO CHARTER OF
DAYTONA BEACH FLORIDA CONGREGATION OF JEHOVAH'S WITNESSES, INCORPORATED

ARTICLE I

The name of the Corporation shall be ~~DAYTONA BEACH FLORIDA CONGREGATION OF JEHOVAH'S WITNESSES, INC. PORT ORANGE FLORIDA CONGREGATION OF JEHOVAH'S WITNESSES, INC.~~, with the principal place of business in the City of ~~Daytona Beach~~, Volusia County, Florida.

ARTICLE II

(Add a second paragraph)

The property of this Corporation is irrevocably dedicated to religious purposes, and no part of the net earnings or assets of this Corporation shall inure to the benefit of a director, officer, or member of the Corporation or any private individual. No substantial part of the activities of this Corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this Corporation participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. This Corporation is organized exclusively for religious purposes within the meaning of Internal Revenue Code Section 501(c)(3). Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States tax code) or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States tax code).

ARTICLE III

Membership in this corporation shall be limited to those individuals who are duly appointed servants elders in an ~~organized congregation of Jehovah's Witnesses in the greater Daytona Beach, Florida area~~ the Port Orange Congregation of Jehovah's Witnesses in the Volusia County, Florida area, operating under the supervision of ~~Watch Tower Bible and Tract Society~~ Watchtower Bible and Tract Society of New York, Inc., as is more fully set forth in the By Laws.

ARTICLE IV

(Add a second paragraph)

Upon the winding up and dissolution of this Corporation, after paying or adequately providing for debts and obligations of the Corporation, the remaining assets shall be distributed to Watchtower Bible and Tract Society of New York, Inc. No assets will be deemed to be received by Watchtower Bible and Tract Society of New York, Inc., until such acceptance is evidenced in writing. If Watchtower Bible and Tract Society of New York, Inc., is not then in existence and exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States tax code), then said assets shall be distributed to any organization designated by the ecclesiastical Governing Body of Jehovah's Witnesses that is organized and operated for religious purposes and is a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding section of any future United States tax code).

ARTICLE XI

When a member of this corporation ceases for any reason to be a duly qualified and acting servant ~~appointed elder in a congregation of Jehovah's Witnesses in the greater Daytona Beach, Florida area~~ the Port Orange Congregation of Jehovah's Witnesses, the said person shall thereupon ipso facto cease to be a member of this corporation. Nor shall any person be a director of this Corporation unless he or she is a duly appointed servant elder in a ~~Congregation of Jehovah's Witnesses in the greater Daytona Beach, Florida area~~ the Port Orange Congregation of Jehovah's Witnesses.
