## ARTICLES OF AMENDMENT OF BLUE SHIELD OF FLORIDA, INC.

1. Article III of the Certificate of Incorporation of Blue Shield of Florida, Inc. is hereby amended to read:

## ARTICLE III

The active membership of this corporation shall be composed of the directors of the corporation while directors of this corporation.

The corporation may provide in its By-Laws for other classes of members and their admission, privileges and rights, but the right of members to vote shall be restricted to the active members of the corporation.

Cumulative voting and voting by proxy are expressly prohibited at any meeting of the active members, and an active member, howsoever qualified, shall be entitled to only one vote at any meeting of the active members.

No incorporator or member, either active or of any class, shall have any vested right, interest or privilege of, in and to the assets. functions, affairs or franchises of the corporation, nor any right, interest or privilege which may be transferable or inheritable or which shall continue after the membership ceases, or while the member is not in good standing. No one can alienate to another membership or any right, interest or privilege of membership in the corporation. When any member dies, resigns, is expelled or otherwise ceases to be a member, he or she and his or her legal representatives and assigns, all and singular, shall be and remain forever in all respects as if he or she had never been a member of the corporation.

2. The foregoing amendment was adopted by the Board of Directors of this corporation on May 23, 1979, and approved by the active members of this corporation on May 27, 1979.
