## FIRST CHURCH OF CHRIST, SCIENTIST, WINTER PARK, FL Certificate of Amendment of Charter

2018

We, Barbara Leigh, Chair of the Executive Board, and Patricia Andrew, Clerk of First Church of Christ, Scientist, Winter Park, Florida, Inc., a non-profit corporation organized under the laws of the State of Florida, hereby certify that at duly and regularly called meetings of the membership held at Winter Park, Florida on Thursdays of September 24, 2015 and September 22, 2016 and May 24, 2018, a quorum being present at all three meetings, the following amendments to the Composite Charter of First Church of Christ, Scientist, Winter Park, Florida, Inc., filed with the Secretary of State of Florida July 19, 1961, and amended on February 27, 1975, filed May 10, 1975, and amended on October 20, 1977, filed January 17, 1978, and amended July 23, 1980, filed December 2, 1980, was adopted by the affirmative vote of more than two-thirds of all members present.

BE IT RESOLVED: That Section 1 of Article VI of the Composite Charter of First Church of Christ, Scientist, Winter Park, Florida, Inc. be amended to read as follows:

- A. The affairs of First Church of Christ, Scientist, Winter Park, Florida, Inc. shall be managed by an Executive Board composed of five members of the Church, all elected by secret ballot.
- B. The annual meeting of the members of the Church shall be held in January of each year at a date fixed by the bylaws of the Church.
- C. Members of the Executive Board shall be elected for a term of three years beginning upon the expiration of the term of their predecessors. Elections to fill vacancies of the Presidency or on the Board shall be held in accordance with the provisions in the bylaws.
- D. The Executive Board shall elect each year from among its members a Chair and a Vice-Chair. The Executive Board shall appoint a Clerk and a Treasurer of the Church. The Executive Board may appoint or remove such other officers or establish or eliminate such other positions as it may deem necessary for the management and operation of the Church.
- E. There shall be a First Reader and a Second Reader elected by secret ballot for a term of one year each at a business meeting to be held in accordance with the bylaws every year. A two-thirds vote of the members present shall be required to elect. Said Readers shall assume their duties on the third Sunday of January following their election.
- F. A President shall be elected by secret ballot at a business meeting to be held in accordance with the bylaws and shall take office at the next regular business meeting to serve for a term of one year. A majority vote will elect.
