

ARTICLES OF AMENDEDMENT TO ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit*Corporation adopts the following amendments to its Articles of Incorporation:

The name of the corporation is: NEW TESTAMENT BAPTIST CHURCH, INC. OF CLEARWATER

A. The new name of the corporation shall be as follows:

THE NEW TESTAMENT BAPTIST CHURCH OF LARGO, INC. DOCUMENT NUMBER: 702776

B. The new purpose of the corporation articles shall be as follows:

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, but are not limited to, promoting the worship of God by the preaching of the Gospel of the Lord Jesus Christ at home and abroad, trusting that as a result sinners shall be saved and believers edified; to establish churches of like faith wherever the Lord shall lead.

C. The Non-Inurement clause shall be as follows:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution statements) any political campaign on behalf of or in opposition to any candidate for public office. Nothwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

D. The Dissolution Clause will be as follows:

Upon the dissolution of the corporation, assets shall be distributed to a like organization exempt under the Internal Revenue Code 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

- E. The amendments were adopted by the members and the number of votes east for the amendments were sufficient for approval.
- F. No additional Articles shall be included or amended.
- G. The date of adoption of the Amendment is November 7, 2021.
