

## Articles of Amendment to Articles of Incorporation of



## ONE SEVEN TWO HOLDING ASSOCIATION INC Document# 702891

Pursuant to the provisions of section 617.006, Florida Statutes and Article X of its Articles of Incorporation, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:

The Board of Directors and the Board of Trustees of One Seven Two Holding Association Inc. (hereinafter "One Seven Two Holding") constitute the officers of One Seven Two Holding. The One Seven Two Holding officers shall be the same elected officers of the American Postal Workers Union, AFL-CIO, Miami Area Local, (hereinafter "APWU"), as described in the APWU Constitution and Bylaws, Article IV, Section 1, "Elected Officers," or future amendments to such section. Pursuant to the APWU Constitution and Bylaws, Article IV, Section 3, "Term of Office," or future amendments to such section, such officers shall be elected to serve a term of three (3) years. All authority of the Board of Directors and Board of Trustees One Seven Two Holding is vested in the elected officials of the APWU Executive Board.

This amendment supersedes any inconsistent language in the original Articles of Incorporation of One Seven Two Holding, filed on September 13, 1961, particularly in Article VI, "Officers to Conduct the Affairs of the Corporation."

This amendment was made on January 21, 2003, and adopted by the members with a sufficient number of votes cast for approval, in accordance with Article X of the Articles of Incorporation of One Seven Two Holding Association Inc. The votes were certified by the American Arbitration Association.
