Pursuant to the provisions of section 617.006, Florida Statutes and Article X of its Articles of Incorporation, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

1. Article XI, 2. currently reads:

2. The highest amount of indebtedness or liability to which the Association may at any time subject itself, shall never be greater than three-hundred (\$300,000.00) thousand dollars.

This section is amended to read:

2. The highest amount of indebtedness or liability to which the Association may at any time subject itself, shall never be greater than 80% of the appraised value of the One Seven Two (172) Holding Association Real Estate Assets.

2. Article XI, 3. currently reads:


3. The largest amount value of real estate which the Association may own or hold shall be one million dollars (\$1,000,000.00).

This section is amended to read:

3. The largest amount value of real estate which the Association may own or hold shall be five million dollars (\$5,000,000.00).

These amendments were made on November 18, 2008, and adopted by the members with a sufficient number of votes cast for approval, in accordance with Article X of the Articles of Incorporation of One Seven Two Holding Association Inc.
