**RESTATED ARTICLES OF INCORPORATION, as AMENDED, of ATONEMENT  
LUTHERN CHURCH, INCORPORATED  
Sebring, Florida**

In the name of God, Amen, the original Articles of Incorporation of this Church adopted in 1959 and amended in 1961 and 1977 are hereby further amended in their entirety to hereafter read as follows:

**PREAMBLE**

This is to certify that we do hereby associate ourselves into a corporation, not for profit, pursuant to the laws of the State of Florida providing for the formation of corporations, not for profit, and to that end we agree as follows:

**ARTICLE I**

The name of this corporation is Atonement Lutheran Church, Incorporated, and said corporation shall be located in Sebring, Florida.

**ARTICLE II**

This corporation is organized for the purpose of providing an edifice or a place of assembly specifically set apart for Christian worship. Therefore we, members of the Body of Christ, desiring to manifest the inner unity, which we have in the common confession, maintenance and defense of our faith in Jesus Christ as God and Saviour, unite in making a plea for the granting of this instrument in our Charter.

**ARTICLE III**

Any person or persons desiring to worship with a Christian church group and who are in accord with the objects of this corporation as set forth more fully in our Constitution and by By-Laws shall be eligible for membership.

**ARTICLE IV**

This corporation shall exist perpetually.

**ARTICLE V**

The affairs of this corporation shall be managed by a Church Council who are active members of the congregation, elected by the congregation at its annual meeting as specified in the Constitution.

The current elected Officers of this corporation are as follows:

#### ARTICLE VII


The Articles of Incorporation, Constitution, and By-Laws of this Church shall be adopted or amended by a majority of the voting members of the Congregation in attendance at the Church's annual meeting, or at a meeting specially set for this purpose. However, any such special meeting shall require thirty (30) days notice to all voting members of the Congregation before such meeting may be convened.


#### ARTICLE VIII

This corporation may subject itself to indebtedness or liability not exceeding two-thirds of the value of the property of the corporation.
