## ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of ST. JOHN VIANNEY COLLEGE SEMINARY, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to articles of incorporation.

FIRST: Amendment adopted: ARTICLE XI is added to the Articles of Incorporation to read as follows:

## "ARTICLE XI

Section 1. The business and affairs of the corporation shall be conducted in a manner consistent with the Code of Canon Law and all applicable directives and teachings of the Roman Catholic Church, the Policies of the Archdiocese of Miami, the Articles of Incorporation and these Bylaws.

- (b) The right to appoint legal counsel;
- (c) The right to appoint the outside auditor;
- (d) The right to approve the capital operating budgets;
- (e) The right of prior approval of the operating philosophy of the corporation and any proposed changes thereto;
- (f) The right to require prior express written approval of any lease, sale or encumbrance of corporate property; and
- (g) The right to require prior express written approval of any proposed merger or dissolution of the corporation."
