RESTATED ARTICLES OF INCORPORATION TARY OF STATE Pursuant to the provisions of § 617.1007, Fla. Stat., the undersigned Sign-for-profit corporation, Document Number 703160, originally incorporated under the name of First Presbyterian Church of North Port Charlotte, Florida, Inc., whose original articles of incorporation were filed with the Florida Secretary of State on November 9, 1961, as amended by that certain Amendment filed with the Florida Secretary of State on July 23, 1986, amending the name of the corporation to First Presbyterian Church of North Port, Florida, Inc., by resolution duly adopted by its board of directors, adopts the following restated and amended articles of incorporation. These restated articles of incorporation include adoption of an amendment pursuant to Fla. Stat. § 617.1007, changing the name of the corporation, and omit of matters of historical interest.

<u>ARTICLE ONE</u> Name of the Corporation

Word of Life Church of North Port, Inc.

ARTICLE TWO Text of the Restated Articles

Purpose: To worship God in Christian community, to study His Word and its application to our lives, to serve Him through the proclamation of the Gospel of Jesus Christ to our community and the World, and to serve our community with Diaconal ministries wherever possible—all in accordance with the teachings of the Old and New Testaments and the Doctrinal, Governmental, and Disciplinary Standards of the Presbyterian Church in America.

Qualifications of members and manner of admission:

All communing members on the roll of the church shall be members of the corporation.

Term of the corporation to exist: Perpetual.

Election and Appointment of Officers: The officers of the corporation are as follows:

Ralph Gross, President.

Board of Directors: There shall be not less than three directors at all times. The method of election of the board of directors shall be stated in the bylaws of the corporation.

By whom and in what manner amendments to the articles of incorporation may be proposed or adopted: At the annual meeting of the members of the Church any member may propose any amendment to the articles of incorporation subject to majority vote of the members entitled to vote or the board of directors by a majority vote.

ARTICLE THREE Article Consolidation

These adopted restated articles of incorporation supersede the original articles of incorporation and all amendments to them.

ARTICLE FOUR Required Adoption Information

These restated articles of incorporation do not contain an amendment to the Articles of Incorporation requiring member approval. These restated articles of incorporation were adopted by the board of directors.

ARTICLE FIVE Effective Date

These restated articles of incorporation shall be effective June 4, 2022.
