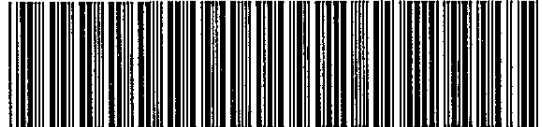

*Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation.*

**NAPLES AREA CHAMBER OF COMMERCE, INC.**, a Florida not-for-profit corporation, organized and existing under the laws of the State of Florida, hereby certifies as follows:

At a duly convened meeting of the Directors of the Corporation, the following resolution was adopted on December 12, 2002, amending the Articles of Incorporation:

FIRST: Article I is hereby amended to read as follows:

**ARTICLE I – NAME**

The name of this Corporation is **GREATER NAPLES CHAMBER OF COMMERCE, INC.**
