TEMPLE EMANUEL INC., a Florida not-for-profit corporation hereby files these Affices LORIDA Amendment to Articles of Incorporation as follows:

- 1. Name. The name of the Corporation is TEMPLE EMANUEL INC.
- 2. <u>Document Number</u>. The Document Number of the Corporation is 703455.
- 3. <u>Filing Date</u>. The Corporation was originally formed by Order of Polk County Circuit Court on October 19, 1948, and filed with the Florida Department of State on January 12, 1962.
- 4. <u>Amendment</u>. The following additional Articles are added to the Articles of Incorporation:

"ARTICLE XI

This Corporation is organized exclusively for charitable, religious and education purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code.
