ARTICLE OF INCORPORATION

of the

CONTRACTOR OF THE PROPERTY OF

NORTH SHORE BAPTIST CHURCH,

WE, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Artickes of Incorporation:

ARTICLE I

NAME

GBAIB The name of this corporation shall be the NORTH SHORE BAPTIST CHURCH, INC., and its principal place of business and place of worship shall be at 50 N.E. 119th Street, in the County of Dade, and State of Florida.

ARTICLE II

PURPOSE

The general purposes and objects of this corporation shall be conduct for religious worship and instruction, churches, schools, parsonages, and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that its own member and others may be generally instructed and guided concerning those Articles of Faith, which are most surely held among Southern Missionary Baptish Churches affiliated with the Southern Baptist Convention, and to advance spiritual growth and enlightenment, moral and personal purity amoung its own membership and the people of the community in which it is located; also to educate, prepare and ordain Christian men for the ministry of the Gospel of Jesus Christ; and for the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself and others, either as Trustee or otherwise. Adopting the following articles of faith:

- 1. We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly That it has God for its author, salvation for its end, and truth, without any mixture of error for its matter; that it reveals the principals by which God will judge us; and therefore, is and shall remain to the end of the world, the true center of Christian union, and the supreme standard by which all human conduct, creeds and opinions shall be tried.
- 2. We believe that there is one, and only one, living and true God, and infinite, intelligent spirit, whose name is Jehovah, the maker and supreme ruler of heaven and earth; inexpressibly glorious in holiness, and worthy of all possible honor, confidence and love; that in the unity of the Godhead, there are three persons, the Pather, the Son, and the Holy Ghost, equal in every divine perfection, and executing distinct but harmonious offices in the great work of mdemption.
- We believe that Man was created in holiness, under the law of his Maker, but by voluntary transgression, fell from the holy and happy state; in the consequence of which all Mankind are now sinners, not by constraint, but by choice; being by nature utterly wold of that holiness acquired by the law of God, positivel inclined to evil; and therefore, under just condemnation to eternate ruin, without defense or excuse.

- 4. We believe that the salvation of sinners is wholly of grace; through the mediatorial offices of the Son of God; who by the appointment of the Father freely took upon Him our nature, yet without sin; honored the divine law of His personal obedience, and by His death made a full atonement for our sins; that having risen from the dead He is now enthroned in heaven; and uniting in His wonderful person the tenderest sympathies with divine perfections, He is every way qualified to be a suitable, a compassionate, and an all sufficient Saviour.
- 5. We believe that the great gospel blessing which Christ secures to such as believe in Him is Justification; that Justification includes the pardon of sin, and the promise of eternal life on principles of rightcousness, that it is bestowed, not in consideration of any works of rightcousness that we have done, but solely through faith in the Redeemer's blood; by virtue of which faith His perfect rightcousness is freely imputed to us of God; that it brings us into a state of most blessed peace and favor with God; and secures every other blessing needful for time and eternity.
- 6. We believe that the blessings of salvation are made free to all by the gospel; that it is the immediate duty of all to accept them by a cordial penitent and obedient faith; that nothing preverts the salvation of the greatest sinner on earth but his own inherent depravity and voluntary rejection of the gospel; which rejection involves him in an aggravated condemnation.
- 7. We believe that in order to be saved, sinners must be regenerated or born again, that regeneration consists of giving a holy disposition to the mind, that it is effected in a manner above our comprehension, by the power of the Holy Spirit in connection with divine truth, so as to secure our voluntary obedience to the gospel; and that its proper evidence appears in the holy fruits of repentance of faith and newness of life.
- 8. We believe that Repentance and Paith are sacred duties and also inseparable graces wrought in our souls by the regenerating Spirit of God; whereby, being deeply convinced of our guilt, danger and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession, and supplication for mercy; at the same time heartly receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on Him alone as the only and all-sufficient Saviour.
- 9. We believe that Election is the eternal purpose of God, according to which He graciously regenerates, sanctifies, and saves sinners; that being perfectly consistent with the free agency of man, it comprehends all the means in connection with the end, that is is a most glorious display of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly excludes boasting, and promotes humility, love, prayer, praise, trust in God and active imitation of Mis free mercy; that it encourages the use of means in the highest degree; that it may be ascertained by its effects in all who truly believe the gospel; that it is the foundation of Christian assurance; and that to ascertain it with regard to ourselves demands and deserves the utmost diligence.
- 10. We believe that Sanctification is the process by which, according to the Will of God, we are made partakers of His holiness; that it is a progressive work, that it is begun in regeneration; and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the Scaler and Comforter, in the continual use of the appointed means, especially the word of God, self-examination, self-denial, watchfulness and prayer.

- 11. We believe that such only are believers as endure unto the end; that their persevering attachment to Christ is the grand mark which distinguishes them from the superficial professors, that a special Providence Watches over their welfare and that they are kept by the power of God through faith unto salvation.
- 12. We believe that the Law of God is the eternal and unchangeable rule of His moral government, that it is holy, just and good; and that the inability which the Scriptures ASCRIBE TO FALLEN MEN TO FULFILL ITS PRECEPTS ARISES ENTIRELY FROM THEIR LOVE OF SIN: to deliver them from which, and to restore them through a Mediator to unfeigned obedience to the Holy Law, is one great end of the Cospel, and of the means of grace connected with the establishment of the visible church.
- 13. We believe that a visible church of Christ is a congregation of baptized believers, associated by covenant in the faith and fellowship of the gospel, observing the ordinances of Christ; governed by His laws; and exercising the gifts, rights and privileges invested in them by His word; and that its only Scriptural officers are Bishops, or Pastors, and Deacons whose qualification, claims, and duties are defined in the epistles to Timothy and Titus.
- 14. We believe that Christian Baptism is the immersion in water of a believer, into the name of the Pather and the Son, and Holy Chost; to show forth, in a solemn and beautiful emblem, our faith in the crucified, buried and risen Saviour, with the effect in our death to sin and resurrection to a new life; that it is prerequisite to the privileges of a church relation, and to the Lord's Supper, in which the members of the Church by the sacred use of bread and wine are to commemorate together the dying love of Christ; preceded always by solemn self-examination.
- 15. We believe that the first day of the week is the Lord's Day, or Christian Sabbath; and is to be kept sacred to religious purposes, by abstaining from all secular labor and sinful recreations by the devout observance of all the means of grace, both private and public; and by preparation for that rest that remaineth for the people of God.
- lo. We believe that civil government is of divine appointment for the interests and good order of human society, and that magistrates are to be prayed for, conscientiously honored and obeyed; except only in things opposed to the will of our Lord Jesus Christ, who is the only Lord of the conscience, and the Prince of the binary of the parth of the kings of the marth.
- 17. We believe that there is a radical and essential difference between the righteous and the wicked; that such only as through faith are justified in the name of the Lord Jesus, and sanctified by the Spirit of our God, are truly righteous in His esteem; while all such as continue in impenitence and unbelief are in His sight wicked, and under the curse; and this distinction holds among men both in and after death.

And we adopt for ourselves the following Church Covenant:

Having been led, as we believe, by the Spirit of God, to receive the Lord Jesus Christ as our Saviour,

And on the profession of our faith, having been haptized in And on the protession of our taith, having been haptized the name of the Father, and of the Son, and of the Holy Ghost, we do now, in the presence of God, angels, and this assembly, most solemnly and joyfully enter into covenant with one another, as one body in Christ, we engage, therefore, by the aid of the Holy Spirit, to wait together in Christian love; to strive for the advancement of this church, in knowledge, holiness, and confort;

To promote its prosperly and spirituality; to austain its within, ordinances, discipling, and doctrines:

ita mership, ordinances, discipling, and doctrines;



To contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and the spread of the gospel through all nations.

We also engage to maintain family and secret devotions; to religiously educate our children; to seek the salvation our kindred and acquaintances:

To walk circumspectly in the world; to be just in our dealings, faithful in our engagements, and exemplary in our deportment;

To avoid all tattling, backbiting, and excessive anger;
To abstain from the sale and use of intoxicating drinks
as a beverage, and to be zealous in our efforts to advance the
kingdom of our Saviour.

We further engage to watch over one another in brotherly love;

To remember each other in prayer; to aid each other in sickness and distress; to cultivate Christian sympathy in feeling and courtesy in speech;

To be slow to take offense, but always ready for reconciliation, and mindful of the rules of our Saviour to secure it without delay.

We moreover engage that when we remove from this place we will, as soon as possible, unite with some other church, where we can carry out the spirit of this covenant and the principles of God's word;

ARTICLE III

USE OF INCOME

All revenue, profit, income and money received from the conduct of such business or enterprize is to be used and employed in religious, educational, charitable, benevolent and missionary work and not for the benefit of the members of said corporation, either individually or collectively.

ARTICLE IV

POWERS

Said corporation is to have the power to do any and all things necessary or expedient for the carrying out of the said objects and purposes of the corporation and in general to possess all rights, privileges and immunities and enjoy all benefits granted to corporations of similar character under the law of the State of Florida.

ARTICLE V

QUALIFICATIONS FOR MEMBERSHIP

Every person who believes in repentence towards God, and faith in Jesus Christ, as Savior and Lord, and who is willing to confess him publicly as Lord and King and follow him in Baptism by emersion, and to observe the ordinances of Christ and be governed by Ris Laws, is qualified and eligible for membership in this corporation.

ARTICLE VI

ADMISSION TO NEMBERSHIP

The manner of admission to membership in said covporation shall be as follows:

MEMBERSHIP BY BAPTISM: Any person professing faith in the Lord Jesus Christ as his Saviour and declaring it as his purpose to follow him as His Disciple, may, by a majority vote of the congregation at any church meeting, be received through Baptism into full membership of this corporation. Those presenting themselves for Baptism may be baptized within twelve months. If they are not baptized within twelve months, they will be dropped from the Baptismal roll and must present themselves

to the corporation again.

MEMBERSHIP BY LETTER: Members of other Baptist churches of like doctrine, who have been baptized according to the New Testament, may, by a majority vote of the congregation at any of its public services, be received into full membership of this church in good and regular standing upon receipt of letters of dismissal from those churches. This vote may be postponed for conference and confirmation when deemed necessary by the Pastor.

A STATE OF THE PROPERTY OF THE

MEMBERSHIP BY STATEMENT: Any person who has professed his faith in Jesus Christ as his Saviour and Lord and who has been examined by the Pastor and the church concerning his baptism, according to the new Testament, may upon statement of the facts and a vow of his Faith and love in Jesus Christ, be received into membership by a majority vote of the congregation at any of its public worship services.

ARTICLE VII

TERM OF EXISTENCE

This corporation shall have perpetual existence.

DIRECTORS

MANAGEMENT OF APPAIRS

The business of this corporation shall be managed by the chairman of Deacons, Vice-Chairman of Deacons, Secretary of Deacons, and Treasurer of the Church shall be President, Vice-President, Secretary and Treasurer, respectively, of NORTHSHORE BAPTIST CHURCH, INC. These corporation officers shall represent the church in all legal matters, and the President and Secretary shall be empowered to execute deeds, described as a mortgages,

liens, promissory notes, or other pecuniary obligations, and to transfer, assign and convey all church property or any part thereof upon officially recorded instructions of the church in conference. In the absence of the President and/or Secretary, the church in business conference, may designate any two other officers to act in such matters.

(a) The Deacons shall elect annually, a chairman and a vice-chairman and a secretary for one year. The Deacons and the Treasurer of the church are elected annually by the members of the corporations as provided in the By-Laws of the corporation.

ARTICLE X

ARTICLE XI

BY-LAWS

The members of the church shall have the right to make and adopt such By-Laws as they shall deem proper and advisable and such By-Laws shall be made, altered, or rescinded upon a two-thirds (2/3) vote of the members present and voting at any regular or special business meeting of the church called for that purpose.

ARTICLE XII

AMENUMENTS TO BY-LAWS AND ARTICLES OF INCORPORATION

The By-Laws of the church and these Articles of Incorporation may be altered, changed, amended by the members of the church in any regular business meeting called for that purpose, provided that proper notice has been given at a previous regular business meeting and provided that also such proposed changes have been submitted to the Deacons for their consideration prior to bringing it to the church for consideration. The Deacons may express approval or disapproval, but final action thereon is subject to the vote of the membership of the church. All such proposed changes, changes or amendments of the By-Laws or Articles of Incorporation must receive the affirmative vote of two-thirds of the majority of the members present voting at such meeting.

(a) Amendments to the Articles of Incorporation when approved by the church must also be forwarded to the Secretary to the State of Florida, and filed and approved by him before the same shall become effective.

NAMES AND LOCATIONS OF CHURCHES

STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA, (Incorporated), incorporated as a non-profit Corporation under the laws of the State of Florida, pursuant to an Order of the Circuit Court of Dade County, Florida, entered on the 29th day of August, 1940, and its Articles of Incorporation approved and filed in the office of the Clerk of the Circuit Court of Dade County, Florida, August 29, 1940, and recorded in Corporation Record Book 49, Page 481, located at 2948 N.W. Second Avenue, Miami, Florida, 33127, will merge into and with NORTH SHORE BAPTIST CHURCH, INC., incorporated as a non-profit Corporation under the laws of the State of Florida, pursuant to Articles of Incorporation filed and approved in the Office of the Secretary of State of Florida on January 10, 1962, located at 50 N.E. 119th Street, Miami, Florida 33146.

MERGING CORPORATION

The Merging Corporation shall be STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA (Incorporated) which shall merge into NORTH SHORE BAPTIST CHURCH, INC.

SURVIVING CORPORATION

The Surviving Corporation shall be NORTH SHORE BAPTIST CHURCH, INC.

PURPOSE OF MERGER

The reason and purpose of the proposed merger is that both members and membership of the two Churches hold to the same religious faith, beliefs, doctrines, practices and interpretation of the Holy Bible, promote substantially the same or

similar programs and it is believed that by combining the physical, material and spiritual resources of the two Church Congregations, that a more effective spiritual ministry will be provided.

EFFECTIVE DATE OF MERGER

The effective date of this merger shall be April 1, 1974. Following the effective date of merger, STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA, (Incorporated), will no longer continue its Church and worship program and ministries at 2948 N. W. Second Avenue in the City of Miami, and will, the restler, transfer all its activities, worship and all further ministries to and jointly with the merged congregation of STANTON MEMORIAL - NORTH SHORE BAPTIST CHURCH/located at 50 N. E. 119th Street, Miami, Florida, except such programs and ministries as may be approved by the merged Congregations.

NAME OF SURVIVING CHURCH

Although the surviving Corporation is NORTH SHORE BAPTIST CHURCH, INC., the actual name under which the combined congregations of the two shall hereafter function and which will be used in all the ministries, organization functions, literature, stationery, cards, mailing and advertising, shall be:

STANTON MEMORIAL - NORTH SHORE BAPTIST CHURCH, INC. and the former names of STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA (Incorporated), and NORTH SHORE BAPTIST CHURCH, INC., will no longer be used for such purposes.

MEMBERSHIP OF SURVIVING CHURCH

The present membership of STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA (Incorporated) and the present membership of NORTH SHORE BAPTIST CHURCH. INC., shall be considered and are accepted as members of STANTON MEMORIAL - NORTH SHORE BAPTIST CHURCH without further action.

OWNERSHIP OF ASSETS BY SURVIVING CORPORATION

The physical assets, property and title to all real estate and personal property presently standing in the name of STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA (Incorporated) shall upon approval of the Articles of Merger by the Secretary of State of Florida, immediately be considered vested completely in the surviving Corporation without further action.

LIABILITIES TRANSFERRED

INC., shall be increased to eighteen (18) and all vacancies created thereby, will be filled by the election to the office of Deacon, the present active Deacons of STANTON MEMORIAL BAPTIST CHURCH OF MIAMI, FLORIDA (Incorporated), to the extent possible and provided such Deacons are willing to serve.

All Deacons, both present and those newly elected, will be elected for such terms as are provided in the By-Laws of NORTH SHORE BAPTIST CHURCH, INC., and all Deacons shall serve terms on a rotation system as provided in such By-Laws.
