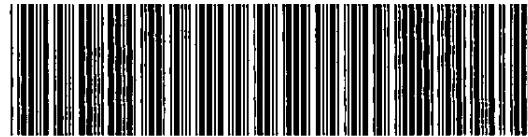


Pursuant to Section 617.1403, Florida Statutes, this Florida not-for-profit corporation submits the following Articles of Dissolution:


FIRST: The name of the Corporation as currently filed with the Florida Department of State is Trailriders Club, Inc.
